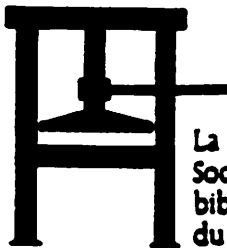

6. BSC/SBC TREMAINE PROJECT.

Among the research tools funded by the SSHRCC and announced in this issue of the Bulletin is a grant to the BSC/SBC for a supplement and index to Marie Tremaine's A Bibliography of Canadian Imprints, 1751-1800. The University of Toronto Press, which holds the copyright to Tremaine, supported the application with a letter expressing interest in publishing the original work (now out of print) together with descriptions of additional imprints and new indexes. I am delighted to have Sandra Alston working with me and we hope that other BSC/SBC members will join us to make this truly a project of the Society/Societe. 7. MARIE TREMAINE FELLOWSHIP INFORMATION

The BSC/SBC will be awarding the second annual Tremaine Fellowships in bibliographical research in 1989. Committee members are Richard Landon (chair), Mary Jane Edwards, and Geneviève Bazin. An application form is included at the end of this issue of the Bulletin. When applying please include specific information about costs including fares, mileage, duration of travel, daily expenses, and technical services or supplies. The application deadline is February 28, 1989. Successful applicants will be announced April 30, 1989.

8. 1988 TREMAINE FELLOWSHIP: REPORT

The project for which I was awarded The Tremaine Fellowship concerns the Dutch piracy of Margaret Mitchell's Gone With the Wind. The book was pirated in the Netherlands by Zuid-Hollandsche Uigever's Maatschappij. Mitchell's American publisher, the Macmillan Company of New York, was unable to prosecute the pirates because the U.S. was not a signatory of the Berne Convention. As a result, Mitchell enlisted the assistance of the Macmillan Company of Canada. A lawsuit was launched in 1937 and was finally won by Mitchell after much litigation in 1946.

When I applied for the Fellowship I had already read a fair amount of secondary literature and had examined archival material in the papers of the Macmillan Company of Canada at McMaster University. To complete my research I travelled to the New York Public Library (to see the papers of the Macmillan Company of New York) and to the University of Georgia (to examine the Mitchell papers). I spent three days at the New York Public Library from May 22 to 25. The papers were poorly organized, and this necessitated an examination of four record storage boxes, which took about 21 hours to complete. From August 28 to 30 I was at the University of Georgia. Mitchell's papers, held at the Hargrett Rare Book and Manuscript Library, in Athens, Georgia, are superbly organized. I located two hollinger boxes which took about 11 hours to read through.

I now feel confident that I know practically everything about the lawsuit that is necessary for the writing of a scholarly article on the subject. As a result of the two research trips I have also written to the National Archives and Record Service in Washington, D.C. There is some relevant material in the papers of the Treaty Division of the State Department. I have ordered abstracts of those documents.

When I applied for the Tremaine Fellowship, the emphasis of my proposal was on the Canadian involvement in the lawsuit and its impact on Canadian publishing of the time. I now think that this emphasis was a bit misplaced. The Macmillan Company of Canada represented Mitchell in two court cases at The Hague in 1938 and 1939. Both cases were lost by the Macmillan Company of Canada. Many court cases followed

thereafter. The complicated story is really a testament to Mitchell's determination to protect her rights as an author and the rights of other American authors. The Canadian perspective is an important element of the story, but it should not distort the larger issue of copyright.

I am truly grateful to the Bibliographical Society of Canada for its financial support of my research. Without such support this research could not have been carried out.

11. A CALL FOR BOOK REVIEWERS

As the new book review editor of the BSC Papers of books written in English, I would be grateful to hear from members of the Society who wish to write book reviews or who think that a particular book should be reviewed in our columns. My objectives are two-fold: to have reviews in the Papers of all significant recently published books on bibliography and publishing history relating to Canada; and to have reviews of all books in this field on non-Canadian topics written by Canadians. I also plan to have some reviews of books that are important in their own right regardless of Canadian content or authorship. I am looking for qualified reviewers who will write critical, researched reviews. In this respect I hope to follow the tradition of my predecessor, Bruce Whiteman, who has now assumed the deserved mantle of editor of the Papers. 12. PUBLICATIONS OF INTEREST TO MEMBERS

BSC President Patricia Fleming was in Ottawa recently to launch her new work, Upper Canadian Imprints, 1801-1841: A Bibliography, published by the University of Toronto Press, in co-operation with the National Library of Canada and the Canadian Government Publishing Centre. Fleming's work continues Marie Tremaine's A Bibliography of Canadian Imprints, 1751-1800. It supplements Tremaine's work with new and previously unlocated imprints. The work covers books, pamphlets, government publications, serials, broadsides, and other printed ephemera. Materials were examined in more than fifty locations in Canada, the U.S., and Great Britain. Each entry follows the principle of descriptive bibliography and includes full collation, contents, type

of paper, typography, and binding. Historical notes deal with authorship, printing, publishing, distribution, and sales. Chronological arrangement allows grouping of imprints dealing with specific events and issues, and demonstrates the spread of printing from Niagara to York, then Kingston, and on through the province. Six indexes provide access by name (author, corporate bodies, pseudonyms), title, place of publication, language, trades (illustrators, editors, publishers, bookbinders), genre, and subject.

The Ontario Association of Archivists (OAA) has recently published Directory of Archives in Ontario. The directory is the OAA's first publication and it is the first such directory for the province. The directory includes 200 entries for archival repositories. Each entry includes the name, address, telephone number, hours of service, and name of the head of the the archival institution. Entries also include a brief note on the scope of holdings, availability of published guides, and features such as accessibility for handicapped persons, participation in inter-archival loan of microforms, and availability of technical equipment. Each entry is indexed according to the type of archives and by location in the province. The directory costs \$7.00 (for OAA members) and \$9.00 (for non-members), plus \$1.00 for postage and handling, and can be ordered by sending a cheque to the Ontario Association of Archivists, Box 3295, Station D, Ottawa, Ont. K1P 5W9.

John Miska, of the Entomology Research Centre Library in Ottawa and a member of the BSC, is the author of Canadian Studies on Hungarians 1886-1986: An Annotated Bibliography of Source Material, published by the Canadian Plains Research Centre (CPRC), University of Regina. The bibliography includes references to monographs, research studies, review articles, theses on Hungary and Hungarians in Canada. The 1300 citations are arranged under more than 30 subject headings. Special features include a comprehensive list of archival holdings, a list of Canadian-Hungarian newspapers, periodicals, in-house publications published by organizations, church groups, and professional associations throughout Canada, and author, title, and subject indexes. The bibliography costs \$35.00 and can be ordered from the CPRC, University of Regina, Regina, Sask. S4S 0A2.

Miska is currently working on a project that will result in the publication of Minority Literatures in Canada: An Annotated Bibliography. The project, supported by a \$75,000 SSHRCC grant, includes about 7,000 references to publications in ethnic and native Canadian literature. The bibliography represents 65 language/nationality groups, providing bibliographic sources on poetry, fiction, and drama, written by people in minority groups. The bibliography will be published in 1989.

Glenn Goluska, of The Nightshade Press in Toronto, has recently designed, typeset, and printed an edition of Blemie's Will, The Last Will and Testament of Silverdene Emblem O'Neill. Blemie, Eugene and Carlotta O'Neill's Dalmation, died of old age in December, 1940.

O'Neill had just completed the second draft of Long Day's Journey into Night and was unwell himself. He wrote the will and gave it to Carlotta to comfort them both for the loss of a "finer friend than most friends". The new edition, printed on the centenary of O'Neill's birth, is limited to 100 copies. The typefaces are foundry and Linotype Palatino, with Egmont Inline Initials, printed damp in two colours on handmade paper at the Imago Hand Paper Mill, Oakland, California. The edition is bound in handmade paper from La Papeterie St-Armand in Montreal. It is 16 pages, 8 3/4" by 5 1/4", and costs \$45.00 postpaid. 14. MARGARET LAURENCE ACQUISITION

A rare first edition of Margaret Laurence's first published book, A Tree for Poverty: Somali Poetry and Prose, has been donated to Trent University's Bata Library. The book, published in 1954 by the Somaliland government, is based on stories told to Laurence by her African housekeeper. Mr. C. James Martin, who knew Laurence in Somaliland, donated his copy of the book after a visit to Trent earlier this year, when he learned the library did not have a copy. Martin was an employee of the Somaliland government and supplied many of the photographs Laurence used in her later book, The Prophet's Camel Bell.
