2. Amtmann and Tremaine Fellowships

The Bernard Amtmann Fellowship is offered in memory of Bernard Amtmann (1907-79), the noted bookseller and specialist in Canadiana. The Fellowship will be offered for the first time in 1992 and every three years thereafter to support the work of a scholar in one of Mr Amtmann's principal areas of interest: Canadiana, book collecting, bookselling, and bibliography. Special consideration will be given to applications from those working on some aspect of the book trade. The Fellowship, which is in the amount of \$1,500, is open to non-Canadians and to those who are not members of the Bibliographical Society of Canada.

The Tremaine Fellowship is offered in memory and through the generosity of Marie Tremaine (1902-84), the doyenne of Canadian bibliographers. The Fellowship was instituted in 1987 and is offered annually to support the work of a scholar engaged in some area of bibliographical research, including textual studies and publishing history, and with a particular emphasis on Canada. The Fellowship, which is in the amount of \$1,000, is open only to members of the Bibliographical Society of Canada.

Both fellowships will be awarded only in support of specific research projects, involving discrete areas of research. Projects which are part of some larger undertaking will not be considered unless they can be completed on their own and can lead to findings which are reportable or publishable in themselves. The funds available are for out-of-pocket expenses such as travel fares and subsistence, and technical services or supplies, and may not be used for salaries or stipends.

Applications should be made on the form attached at the end of this issue of the *Bulletin* and must be accompanied by a detailed budget proposal, a full *curriculum vitae*, and two sealed letters of reference. They should be mailed to The Chair, Fellowships Committee, Bibliographical Society of Canada, P.O. Box 575, Postal Station P, Toronto, ON M5S 2T1, and must be postmarked no later than 28 February 1992.

4. Notice of the National Conference in Charlottetown

The Third National Conference on "Canadian Bibliography: Achievements, Challenges, and Opportunities" is sponsored by the Association for Canadian Studies, the Bibliographical Society of Canada, and the National Library of Canada. The conference will be held with the Learneds in Charlottetown, Prince Edward Island, on 31 May and 1 June 1992.

The purpose of this third national conference is to review progress since the first national conference in 1974; to identify existing gaps within Canadian Bibliography; to examine the impact of technology on bibliography; and to make recommendations to close the gaps and to increase the dissemination of bibliographies.

Plans include four keynote speakers: Ernie Ingles, G. Thomas Tanselle, Robin Alston, and another to be confirmed. Over the two-day period there will be ten concurrent sessions. There will be two sessions each morning and one each afternoon. Each session will be 90 minutes long. Two subject areas will be discussed at each session and at each session there will be a chair, a presenter for each subject, and a respondent. The two presenters will have 20 minutes each, the respondent 10 minutes, and the remaining 15 minutes will be given to audience discussion. The chair and respondent will be responsible for taking the results of each discussion to the plenary session at the end of the conference. There will also be a session devoted to bibliographies in progress. Resolutions will come forward from the plenary session. For further information and to make suggestions, contact: Eric L. La troisième conférence nationale sur "La bibliographie canadienne: Réalisations, défis, perspectives" est parrainée par l'Association d'études canadiennes, la Société bibliographique du Canada et la Bibliothèque nationale du Canada. Ce congrès se tiendra dans le cadre des réunions des Sociétés savantes à Charlottetown, à l'Île-du-Prince-Edouard, du 31 mai au 1er juin 1992.

Cette troisième conférence nationale a comme objectif d'examiner les progrès effectués depuis la première conférence sur la bibliographie de 1974; d'identifier les lacunes existant dans le monde de la bibliographie canadienne et de son soutien aux études canadiennes; d'examiner l'impact de la technologie sur la compilation et la dissemination des bibliographies; de faire des recommandations pour combler les lacunes et accroître la dissémination des bibliographies.

6. SSHRCC Terminates Canadian Studies Research Tools Program

The Social Sciences and Humanities Research Council of Canada has decided to terminate the Canadian Studies Research Tools Program. Initiated by SSHRCC in 1981-82 to further the development of Canadian studies, the CSRT program has funded archival and bibliographical projects to a maximum of \$75,000 per year or a maximum of \$250,000 for a three-year period. The last competition of the CSRT program was held in 1991. Candidates have now been notified or the results of the CSRT competition. Projects, which received funding in previous years, were listed in the fall issue of the *Bulletin* and have also been listed in SSHRCC's Annual Reports.

Although SSHRCC has eliminated the CSRT program it will continue to provide funding for research tools in general through its Research and Strategic Grants programs. SSHRCC will be integrating support for the creation of research tools, beginning with the competitions of 15 October 1992. Criteria regarding the eligibility of applicants, the eligibility of proposals, selection, and the evaluation process are now being drafted by SSHRCC. Applicants who wish to apply for funding of a research tool, but who are uncertain of the appropriate program, are advised to contact Julie Dompierre, Social Sciences and Humanities Research Council of Canada, P.O. Box 1619, 255 Albert Street, Ottawa, ON K1P 6G4.

The Council of the Bibliographical Society of Canada will be monitoring the integration of research tools into SSHRCC's regular programs. Members of the BSC who apply to SSHRCC for funding of a bibliographical project in future competitions are asked to inform the President of the BSC Council of the success of their application or of any difficulties incurred.

8. Notice of New Projects

An Index to the Canadian Bookman (1909-1910, 1919-1939) will be compiled by Grace Heggie and Anne McGaughey, York University, as a sabbatical project during 1992. Duncan McLaren will publish and distribute the publication since the Index will provide access to his microfilm of the Canadian Bookman.

Canadian Magazine (v. 1-91, 1893-1939), a significant periodical, deserves a complete and modern index. Grace Heggie expects to begin work on this project in 1994. An "annotated" index is planned, perhaps using the abstract field in the Authex program as a means to provide notes. Any publication that may result from this work shall be dedicated to the memory of Beth Miller.

9. Notes and Queries: Penal Press Publications

Robert Gaucher and Curtis Taylor are seeking information about holdings of Canadian Penal Press publications. These publications have been produced by prisoners in Canadian penal institutions since 1949. They have discovered that primary collections are lodged in the National Library, university libraries, and in provincial archives. Their research to date has identified approximately 2,000 issues under 130 titles. Their intention is to create one inclusive collection of the scattered remnants which will be held in the University of Ottawa Library Documentation Centre. In the meantime they also intend to construct the history of this fascinating and little known Canadian medium, especially as it relates to Canadian penal reform. They are interested in detailed information on holdings and on access for reproduction. Marlys Chevrefils, Special Collections, University Libraries, University of Calgary, has compiled *The Clark Blaise Papers: First Accession and Second Accession: An Inventory of the Archive at the University of Calgary Libraries* (University of Calgary Press 1991). This is the fourteenth volume in the Canadian Archival Inventory Series and was funded by SSHRCC Research Tools Program. The series is edited by Hallvard Dahlie and this volume was edited by Jean Tener, University Archivist, and Apollonia Steele, Special Collections Librarian. The biocritical essay is by Catherine Sheldrick Ross, University of Western Ontario.

The Edgar and Dorothy Davidson Collection of Canadiana at Mount Allison University, compiled by the staffs of the Centre for Canadian Studies and the Ralph Pickard Bell Library under the general editorship of Dr. Larry McCann, Davidson Professor of Canadian Studies, has been published. The Davidson Collection of Canadiana is a minor treasure of nearly 600 rare first-edition books and early imprints spanning the seventeenth to the nineteenth centuries. This bibliography is organized in five main sections: French and French Influence, English and English Influence, Arctic Exploration, The Western Frontier, and Early Canadian Imprints. Among the vivid accounts of Canadian exploration and settlement are personal testimonies of battles, ethnographies of Native peoples, early histories of the country, scientific and religious treatises, and examples of government propaganda. Accompanying the full bibliographic entries are about seventy illustrations. There are also indexes to authors, titles, publishers, printers, maps, cartographers, illustrators, works by genre, and subjects. 13. News from the Thomas Fisher Rare Book Library

"Eric Gill: His Life and Art" is featured in an exhibition at the Thomas Fisher Rare Book Library through December 1991. The majority of drawings, prints, and books come from a major private collection in Toronto and have not been publicly exhibited for fifty-seven years. Other items come from the University of Waterloo, Massey College Library, the Fisher Library, and the private collections of Richard Landon, Alan Horne, and Douglas Chambers. A catalogue of the exhibition, priced at \$20 is available from the Office of Development, Robarts Library, University of Toronto. The exhibition was officially opened on 23 October with a lecture on "Eric Gill the Artist" by Joshua Heller, an antiquarian bookseller and collector from Washington, D.C., who specializes in private press and illustrated books.

The Friends of the Fisher Rare Book Library are also sponsoring other lectures for the 1991-92 season. On Tuesday, 19 November 1991, Guy Debenham, a Canadian wood engraver, will talk on "The Hidden Art of Bookplates." On Thursday, 13 February 1992, Patricia Fleming will speak on the search for imprints, the nature of analytical bibliography, and the book trade in early Canada. The season will end with a talk on Monday, 27 April 1992, when Anthony Rota, an antiquarian bookseller from London who specializes in modern English literature, will speak on "A Week in the Life of a London Bookshop."

15. Notes from the Canadian Library Association Special Collections Interest Group Newsletter 1991

McMaster University Library announced that the William Ready Division of Archives and Research Collections has acquired the files of Canadian authors from the archives of the American publisher Dodd, Mead and Co. Funds to purchase the papers were provided by a Movable Cultural Property grant of \$18,400 from the Ministry of Supply and Services - Communications, Canada. The files contain letters written by important Canadian authors, contracts sent to these authors for their signature and revision, correspondence with other publishers, internal memos, sales figures, printing information, and publicity material. Among the authors represented are Bliss Carman, Blodwen Davies, Philip Freund, John Murray Gibbon, Grey Owl, W.G. Hardy, Stephen Leacock, and Martha Ostenso. This material is a significant part of Canada's literary heritage. McMaster University Library already housed the publishing archives of McClelland and Stewart, the Macmillan Co. of Canada, Clarke Irwin, and Peter Martin Associates. (At McMaster a bibliography of all the publications issued by McClelland and Stewart from 1906 to 1985 is being compiled with the aid of a SSHRCC Canadian Studies Research Tools grant.) The Dalhousie University Libraries is establishing a Canadian Literary Collections Project (CLCP), which will collect the published works and manuscript collections of Canadian contemporary authors of imaginative works in fiction, drama, and poetry; small press publications, literary periodicals, and selected works about contemporary literature. The papers and records of individuals or organizations related to the literary community and publishing will be collected, as will audio and video tapes of interviews, performances, readings, and other programs that may arise out of the activities of the CLCP. 
