NEWS LETTER, APRIL, 1950

The annual meeting of the Bibliographical Society of Canada will be held at the Mount Royal Hotel, Montreal, on Tuesday, June 13, taking the form of a noon luncheon at which Dr. W. Kaye Lamb, Dominion Archivist, will be the special guest and will speak on some special aspects of his work in connection with the establishment of the Canadian National Library. This will be of particular interest to members of our Society. Officers will be elected and reports presented on the work of the Society during the past year. Members of the Society will already have received No. 3 in the Reprint Series, being a reproduction of "Sawney's Letters" an exceedingly rare British Columbia item, with an introduction by Dr. W. Kaye Lamb. A fourth reprint, which will, we think, be highly valued, is in preparation and it is expected that it will be in the hands of members before the annual meeting in Montreal. It is planned to continue this series until all the ten provinces are represented. There have been many commendations for the reprints which have already appeared and one library has ordered a second set. It may be expected that the little booklets will in time become collectors' items as the number printed is limited.

In reply to a questionnaire sent out by the Secretary of the Society, replies which have been received indicate that a very considerable amount of valuable bibliographical work is in progress at the present time throughout Canada. The Secretary of the Society would appreciate hearing of any additions to the following list which came in answer to her inquiry:

Mr. Conrad Morin mentioned that he had just received the complete work of Th. Besterman, A world bibliography of bibliographies, 3 vols. London 1947-49, and was much pleased with it.

Mr. Willard Ireland mentioned the reproduction by R.R. Reid of Vancouver of a limited edition, hand set and privately printed, of Alfred Waddington's "Fraser River Mines Vindicated", one of the rarest B.C. imprints.

Miss Grace Lewis mentioned that Miss Audrey MacGregor of the D.B.S. Library is preparing a Newfoundland bibliography.

Attention may also be drawn to the publication in February issue of the Canadian Library Association's Bulletin of Mlle Chabot's list of bio-bibliographies by pupils of the University of Montreal Library School.
