MINUTES OF THE 58th ANNUAL GENERAL MEETING OF THE SOCIETY

The 58th Annual General Meeting of the Bibliographical Society of Canada/Société bibliographique du Canada was held on Monday June 16, 2003/ lundi, le 16 juin, 2003 at the Toronto Reference Library, Toronto, Ontario.

The meeting was called to order at 3: 40 p.m.

- 1. Welcome from the President: Gwen Davies welcomed all members to the Annual General Meeting. She thanked the staff of the Thomas Fisher Rare Book Library for hosting the book launch and reception on June 15, the Faculty of Information Studies at the University of Toronto for providing the room for the panel discussion, and the Toronto Reference Library for hosting the day's conference sessions.
- 2. Minutes of the 2002 Annual General Meeting: Gwen Davies called for additions, corrections or discussion. There being none, it was moved by Sandra Alston, seconded by Patricia Fleming, that the minutes be approved. CARRIED.
- 3. **Report of the President**: Gwen Davies presented the proposed revision of the goals and objectives of the Society, as endorsed at the 57th Annual General Meeting, and printed in the Spring 2003 *Bulletin*. She commented that the changes are necessary because of a rapidly expanding academic environment, and that the Society's initial goals and objectives were drawn up in a different time. Discussion followed regarding the desirability of the Society resuming its publishing objective, as well as encouraging the research and publishing projects of others, especially graduate students. It was noted that the term "formats" includes the electronic medium. Peter McNally proposed to move the 4th objective "To further the study, research, and publication of book history and print culture" to the #2 position. There were no objections.

MOTION: That the membership of the Bibliographical Society of Canada/Société bibliographique du Canada endorses the adoption of the revised goals and objectives.

Moved by Peter McNally, seconded by David McKnight. CARRIED.

Gwen Davies reported on the Society's relationship with the Canadian Federation for the Humanities and Social Sciences. She participated in a Fall 2002 session on the needs of small societies, and is a member of the 2003 nominating committee. Although we have not been meeting annually with the Congress, the Society does want to maintain its presence in the Federation, and therefore organized a joint BSC/ACQL (Association for Canadian and Quebec Literatures) session on the History of the Book for the 2003 Congress. Gwen Davies reported that a sub-committee of Council has been formed to identify societies with like interests to the Bibliographical Society of Canada, and to recommend methods to broaden the Society's activities across Canada and internationally. The committee consists of Council members Carl Spadoni (chair), Josée Vincent, and David McKnight, and Apollonia Steele from the membership at large. The committee will meet via email, and report to Council.

Gwen Davies thanked Ralph Stanton and the fundraising sub-committee for their work in organizing the fundraising approach of the Society, and reported that the initial campaign has begun with a selective mailing.

4. **Report of the Treasurer**: Elaine Hoag presented the accountant's review engagement report, which shows almost identical fund equity this year compared to last year (\$194,000). The modest profit of between \$5,000 and \$10,000 that we generally enjoy (and that in the past has allowed us to purchase additional investments), in 2002 financed the project to digitize the *Papers/Cahiers* (\$3, 970) and allowed us to join the Canadian Federation for the Humanities and Social Sciences (\$1,820).

Although our average rate of return on investments in 2002 was 4.46%, this will increase to 4.967% in 2003.

Membership in 2002 stood at 283—the highest in the last five years. Our membership fees continue to cover the cost of producing the *Papers/Cahiers*, the *Bulletin*, and administrative expenses such as postage and photocopying. The 2002 Halifax conference netted a profit of \$484.

The Tremaine Fellowship Account is financially very solid. Due to the ongoing generosity of members, the Amtmann Account investments will earn sufficient income to award the scholarship in 2004, 2007 and 2010. The addition of Dorothy Ryder's bequest (\$5,000) to this fund will put the fellowship on a much firmer footing.

Bernard Katz noted that our membership in the Canadian Federation for the Humanities and Social Sciences might entitle us to a rebate connected with conference registration fees, if we hold our conference with other member associations. E. Hoag will contact the Federation to explore this and other advantages of membership.

Patricia Fleming raised the topic of royalties. General fund royalties are chiefly from Cancopy (renamed Access Copyright) and arise from the *Papers/Cahiers* and the *Bulletin* (\$1,115.18), with a small amount from U. of T. Press for BCB3 (\$17.85). Royalties for Tremaine and Fleming/Alston are deposited in the Tremaine account. Sandra Alston questioned if our royalties would decrease after we mount the *Papers/Cahiers* on our website, but since Access Copyright distributes royalties by means of a pre-determined format that does not take digitization into account, our royalties are unlikely to be affected. E. Hoag will monitor payments over the coming year.

Joan Winearls and Mary Williamson enquired if conference organizers receive a budget. E. Hoag replied that organizers are expected to break even by setting a registration fee that covers expenses. J. Winearls and M. Williamson will submit a proposal to Council regarding the possibility of making extra money from general funds available for conferences.

Adoption was moved by Elaine Hoag, seconded by Janet Friskney. CARRIED.

- 5. **Report of the Secretary**: Anne McGaughey reported that a personal membership list, containing addresses, emails and research interests, was prepared and sent to members in Fall 2002. She thanked Sandra Alston for her help in this undertaking, and for her continued maintenance of the membership database. She also thanked Pierre Ostiguy, the Associate Secretary, for his thoroughness and promptness in providing French translations of various documents. Reminders have been sent to all who have not paid membership dues for 2003. The Society has so far welcomed 16 new members in 2003. The Secretary's files now contain the copyright assignments collected by Basil Stuart-Stubbs, and will be the continuing repository.
- 6. **Report of the Nominating Committee**: Peter McNally, the Chair of the Nominating Committee, presented the following slate of officers for election, 2003-2004, and called for further nominations:

President – Gwen Davies; 1st Vice-President – Carl Spadoni; 2nd Vice-President – David McKnight; Treasurer – Elaine Hoag; Secretary – Anne McGaughey; Associate Secretary – Pierre Ostiguy;

Council members 2003-2006:

Clarence Karr, Bill Moreau, Karen Smith.

There being no further nominations, adoption of the report was moved by Peter McNally, seconded by Joan Winearls. CARRIED. All positions were declared elected.

- 7. **Report of the Publications Committee**: Basil Stuart-Stubbs, the Chair of the Publications Committee, reported that copyright permission has been requested from individual authors and co-authors of articles in the *Papers/Cahiers*, vols. 1-40, in accordance with the wishes of the membership as expressed at the 2002 Annual General Meeting in Halifax. Only 4 authors have not as yet responded; 105 have assigned copyright to the Society; 8 have declined to assign copyright, but have granted permission for digital conversion of their articles; and 1 author has declined to assign copyright or to permit digital conversion. Council agreed that authors of reviews should contact the Society if they do not wish their reviews to be digitized, and an announcement will be made in the *Bulletin* to this effect.
- B. Stuart-Stubbs reported that Council has approved the adoption of a style guide for English articles in the *Papers/Cahiers* and the *Bulletin*, developed by Sheila Latham to help achieve consistency and simplify editorial practices. The guide will not necessarily apply to writers of reviews. A style guide for editing in French is forthcoming.
- B. Stuart-Stubbs announced that Patricia Belier will be the new editor of the *Bulletin*. He thanked David McKnight for his years of service as *Bulletin* editor, and Sheila Latham for her work as editor of the *Papers/Cahiers*. B. Stuart-Stubbs reported that the Publications Committee will be reviewing the contents of the *Bulletin* in relation to the Society's website, in consultation with Sandra Alston.

Patricia Fleming raised the issue of the Society's involvement in the publication of monographs.

B. Stuart-Stubbs indicated that the Society is not in a position to undertake independent publishing, but that it could possibly form alliances with university presses.

B. Stuart-Stubbs reported that Council has approved that the Society join the Canadian Association of Learned Journals, which acts as a collective voice for scholarly journals, in the areas of education, promotion and lobbying.

The presence at the meeting of David Hayne, founding editor of the *Papers/Cahiers*, was acknowledged.

8. **Other business**: Josée Vincent announced the formation of a new programme at the Université de Sherbrooke, the Certificat en histoire du livre et de l'édition.

Ralph Stanton, the Chair of the Fellowships Committee, announced that the Tremaine Fellowship has been awarded to Craig Wilson, doctoral candidate at Osgoode Hall Law School, who will research the journal *Secular Thought* (Toronto, 1887-1911). R. Stanton reminded applicants for fellowships to join the Society before submitting their proposals, and encouraged scholars to apply for the Tremaine and Amtmann Fellowships in 2004.

- 9. **Date and place of the next Annual General Meeting**: Carl Spadoni announced that the Society plans to meet at McMaster University in Hamilton from June [27]-29. The theme of the conference will be "Publishing history/ L'histoire de l'édition."
- 10. **Adjournment**: Moved by Peter McNally, seconded by David McKnight, that the meeting be adjourned at 4:30 p.m. CARRIED.

Papers/ Cahiers Digitisation Project Update:

The project to convert the *Papers/Cahiers* into full-text has now entered the third and final phase. During the first phase of the project, the *Papers/Cahiers* were scanned by the University of Toronto Library under the direction of Karen Turko. At the same time, the Chair of the Publication Committee, Basil Stuart-Stubbs, undertook the momentous task of both seeking copyright permission from all the authors of papers which have been published in the Society's journal since 1962, and, standardizing the Society's copyright policy with respect to the *Papers/Cahiers*.

In February 2003, the second phase of the project was launched and was completed last November. This phase focused on editing the text files using optical character recognition (OCR) software. With the page images and text files stored on a server at McGill, a student dedicated to the project undertook the onerous task of editing every text file to insure that any errors that occurred in the OCR process were corrected.

Currently, two students have begun to "tag" the text files in XML (Extensible Markup Language is a standards based language that is used to encode documents). The Digital Collections Program which is undertaking the technical conversion of the *Papers/Cahiers* has developed a journal DTD (Document Type Definition) which is being used to define the core elements within each issue of the *Papers/Cahiers*.

The choice of XML over alternative formats like PDF, for example, is that it is non-proprietary and is supported by the World Wide Web consortium. It is being widely adopted and serves as a preservation format which will insure that the electronic texts that are being generated will be preserved over time. The additional benefit of adopting XML and a well-designed DTD is that it will facilitate extending the searching of the full-text corpus of the *Papers/Cahiers* beyond simple keyword. The goal is to exploit and integrate tools that have been generated to date including the subject indexing of the journal.

During the current phase of the project, we are developing the search engine and designing the search and results pages. This project is modeled on the JSTOR project which many members will be familiar with.

Based on our current production schedule the tagging of the *Papers/Cahiers* in XML will be completed by the end of August. The project will be launched in October as part of the re-design of the Society's web site. The University of Calgary :

There are several exciting highlights to report from Special Collections. Among the book donations received in 2003 is a unique artist's book from Lise Melhorn-Boe titled *Bound by Convention 2*, a work consisting of 6 plywood cut-outs measuring 184 cm. We also received extraordinary funding to acquire other works by Lise, thereby strengthening our bookworks collection.

The second collection of great interest is the William Whitehead Collection of Timothy Findley's Works, personally inscribed to William Whitehead. The collection has been designated as meeting the criteria set by the Canadian Cultural Property Export Review.

We were allocated special funding to purchase a first impression dated April 1908 of L. M. Montgomery's *Anne of Green Gables*. Planning is underway for an exhibit of editions and impressions of Montgomery's works during the CLA meeting in Calgary in June 2005.

New accessions of literary and music archives were received including an accession of the ECW PRESS fonds and a major addition to the Guy Vanderhaeghe fonds. A new archive from poet and journalist Zoë Landale has been acquired.

A grant was received from the Archives Society of Alberta which, with matching grants from our Information Resources, will enable us to appraise, arrange and describe the *Descant* fonds.

The Association of Book Publishers of British Columbia has announced that **Basil Stuart-Stubbs** is the recipient of the fifth annual **Gray Campbell Distinguished Service Award.** Basil is being recognized for his outstanding contribution to the book industry in British Columbia. The Association's press release cited Basil's many contributions to the writing and publishing community in B.C. such as his organization of the 1974 conference leading to the formation of the BC Publishers Group and his work for two important Canadian literary magazines: Canadian Literature and Prism International. He was one of the founders, in 1965, of the Alcuin Society and in 1967, he and bookseller Bill Duthie collaborated in the production of the first edition of Canadian Books in Print. As Chairman of the UBC President's Committee on University Publishing, he was instrumental in establishing UBC Press and served as the founding Chair of its Board from 1970 to 1982. "Writers too owe a debt to Basil Stuart-Stubbs for his lobbying efforts to establish the Public Lending Right legislation that compensates all Canadian authors for the use of their works in public libraries. Despite these important accomplishments made on behalf of publishers, librarians, booksellers and writers, Basil Stuart-Stubbs remained a behind-the-scenes activist, who quietly and with considerable grace used his influence, power and skills to change the lives of publishers and so many others in our community."
