A message from David McKnight, President of the BSC

It has been six months since the Society held its annual meeting in June 2006. The Society met in conjunction with the annual Federation of the Humanities and Social Sciences Congress held at York University. Over forty members of the Society registered for the one and a half-day programme. This year's meeting included the presentation of seven papers and a half-day plenary session dedicated to identifying issues and themes for discussion related to the planning of the 4th National Conference on Canadian Bibliography. In addition to the Call for Papers, there is more information in this issue of the *Bulletin* on the conference itself. Suffice to say that the 4th National Conference, entitled **Beyond the Text: Bibliography in the Digital Age** will be a significant event and will be held in Montréal from 20-22 June 2007.

In June a new slate of members joined the BSC Council and I hope you join me in welcoming them. Carl Spadoni, now Past-President, presided over his last council meeting as President and David McKnight was elected the Society's new President. Anne Dondertman is now 1st Vice-President and Paul Aubin will serve as 2nd Vice-President. I would like to extend, on behalf of the membership, a warm thank you to Carl for his dedicated work on behalf of the Society during his term as President.

Other changes of note include the fact that two former Presidents of the Society have re-joined Council in key positions. Last spring, Patricia Fleming agreed to serve as chair of the Publications Committee, after Basil Stuart-Stubbs announced his retirement. In September 2006, Tom Vincent kindly agreed to serve as the Society's Treasurer. On behalf of the Society, I would like to thank Pat and Tom, who both recently retired, for volunteering to re-join the Council and help us shape the Society's future. At the same time, I would like to express my deep gratitude to Elaine Hoag who served as the Society's Treasurer for almost a decade. She managed our finances with care, professionalism, and aplomb. Merci Elaine.

Anne McGaughey, the Society's equally capable Secretary has announced that she intends to retire in June 2007. Thus we are in search for a new Secretary. As a volunteer organization, the Society is wholly dependent upon individuals who generously offer their precious free time with like-minded individuals who, in our case, share a passion for bibliography and the stewardship of one of Canada's foundational scholarly societies. Thanks to all.

Although Council is focusing much of its energy on planning the Montréal conference, we are still facing critical issues which impinge upon several of the initiatives that were launched during the past five years. These include addressing the Society's hope to operate a cost-effective, but editorially sound, publications programme in both print and electronic formats.

Moreover, it is essential that we continue to raise adequate funds to support publications, scholarships, and the work of the Society in general. We are certainly grateful to all of you who made donations this year. Although our membership is surprisingly vibrant in terms of individual memberships, we continue to seek ways to attract graduate students, in particular, into our fold. We also wish to seek alliances with similar organizations in Canada and abroad.

Some of you will recall that the Society, through the efforts of Pat Fleming and the National Library of Canada, hosted the Institute for Canadian Bibliography in 1993 and 1995. Council has discussed the feasibility of reviving the Institute and I am pleased to report that Carl Spadoni has volunteered to plan and preside over a week-long course at the University of Toronto during the summer of 2007 (see page 6).

As you read this, June 2007 will be looming six months on the horizon. It is my hope that you will examine the Call for Papers with interest and consider submitting a proposal. La Grande Bibliothèque has graciously partnered with the Society agreeing to waive fees for the venue and provide support services. In light of this generous offer, I hope that as many of you as possible will consider joining us in Montréal to explore the future of bibliography in the digital age.

•Birth of the BSC - Sixty Years Ago!

IN 1942 proposals were made among a number of bookmen across the country, to form a Bibliographical Society of Canada. There seemed a genuine need of some organization to promote research into Canadian bibliography, on both the creative side and the technical side, both on writers and their work and on printers and their work. . .

After some discussion in 1942 it was decided to delay any active steps towards organization till the war had ended, but to appoint in the meantime, a temporary committee — Lorne Pierce, E. C. Kyte and Marie Tremaine — who worked out the journal objectives, the main lines of the constitution and the foundation membership of the Society.

A year ago correspondence opened again among about thirty people in different parts of the country, and on May 30th, 1946, a meeting was held at the University Club, Toronto, to explore the possibility of organizing a society. Dr. Lorne Pierce was host and fourteen persons were present.

It was generally agreed that bibliographical material existed in Canada, of a kind and quantity to warrant a publishing society; that a new organization should concern itself with material in fields not represented by existing learned journals published in this country; that it should co-ordinate bibliographical activity and set standards. It was decided at this meeting to organize the Bibliographical Society of Canada.

BSC Annual Conference, Montréal, 20-22 June 2007

•Call for Papers BSC 2007

Since 1970, the Bibliographical Society of Canada (www.library.utoronto.ca/bsc) has organized three national conferences on the state of Canadian bibliography. Each national conference explored a range of issues and concerns pertinent to the state of analytical, descriptive, enumerative, and thematic, among other types of bibliographies, all of which contributed to the identification and location of Canada's printed heritage. The national conferences also served as a vehicle for identifying gaps in the bibliographical past, theory and practice and, of course, standards and training. In essence it might be said that the national conferences gave the BSC time to reflect upon its role and, at the same time, to identify priorities within the national context.

It is fair to say that over the course of the past 36 years, there has been an enormous sea change on three fronts. First, building upon the labours of Marie Tremaine and the Toronto Public Library, the National Library of Canada, Bibliothèque et Archives nationales du Québec (BAnQ), and national initiatives such as CIHM, as well as publicly funded projects such as the Annotated Bibliographies of Canada's Major Authors (ECW Press) and the work of individual scholars who have produced major bibliographies, our knowledge of Canadian printed output is staggeringly improved, thus researchers and scholars have greater access to primary sources than ever before.

Second, the discipline of analytical bibliography, whose origins are traced back to the beginning of the 20th-century with the pioneering work of McKerrow, Greg, and Bowers, has had wide dissemination and influence in Great Britain, North America and Australia. Bowers' "Principals" served as the foundation for graduate study in English for three decades. By the 1980s such scholars as Robert Darnton and D.F. McKenzie were questioning the primacy of the physical object of the book and opening the field of research. At the same time, the emergence of the study of book history and the rise of the national histories of the book placed greater emphasis upon authorship, publishing and reading than the more narrowly focused concerns of bibliography. The rise of book history has forced organizations such as the BSC to re-examine its objectives and role within the changing context of the study of book culture in the broadest sense.

Third, in parallel with the rise of book history and the measurable decline in the interest in analytical bibliography, the unexpected phenomenon of hypertext, digital facsimiles, and the World Wide Web has had enormous impact on the accessibility to electronic renderings of primary texts, the production of bibliographies, and the study of book history. With such projects as Early Canadiana Online, Early English Books Online, and NINES, scholars are learning and adapting to the unexpected possibilities of humanities computing. In certain respects, at the same time as monumental scholarly projects, like the three-volume *History of the Book in Canada*, draw to completion, new questions will arise. Thus the Bibliographical Society of Canada on the occasion of the 4th National Conference on Canadian Bibliography has identified the following theme:

Beyond the Text: Bibliography in the Digital Age. In collaboration with the kind support of Bibliothèque et Archives nationales du Québec (BAnQ), the conference will take place in Montréal from 20-22 June 2007 at the Grande Bibliothèque of BAnQ.

The Program Committee invites proposals for papers to be delivered on the following themes:

- Surveying the field: how traditional practices in all forms of bibliography are being impacted by the digital world
- Theory and Practice: theoretical and practical examples of the cross-currents between traditional bibliography and the field of book history and print culture
- Training and standards: evolving standards in descriptive metadata and the place of bibliography in the academic curriculum

Papers are invited from all interested researchers in the fields of Canadian bibliography, history of the book, and the digitization of collections. We are especially interested in analytical presentations from new scholars and graduate students.

Members of the Society are eligible for conference travel / accommodation grants. Please see the application form on pages 11-12 for details. **Student members have priority for financial support to attend our annual conference and/or to present papers.

SbC congrès annuel, Montréal, du 20 au 22 juin 2007

•Demande de communications SbC 2007

Depuis 1970, la Société bibliographique du Canada (www.utoronto.library.ca/bsc/) a organisé trois colloques nationaux sur l'état de la bibliographie au Canada. Lors de ces colloques, les intervenants se sont penchés sur divers aspects de la bibliographie, qu'elle soit analytique, descriptive, énumérative ou thématique, et ont contribué, ce faisant, à l'identification et à la localisation du patrimoine imprimé canadien. Les trois colloques ont en outre permis de faire évoluer les connaissances sur l'histoire du livre et de l'imprimé au Canada et ont fait connaître les besoins les plus criants dans ce domaine, sur les plans autant théoriques que pratiques. Ils ont également permis à la Société d'identifier les priorités et les enjeux liés au développement de ce champ d'étude à l'intérieur du contexte national et de (re)définir son rôle à cet égard.

Au cours des 36 dernières années, des changements majeurs ont marqué le champ d'étude de la bibliographie, et ce, sur trois plans. Premièrement, notre connaissance de la production imprimée canadienne a été grandement enrichie par les travaux de Marie Tremaine et par ceux des nombreux chercheurs qui ont œuvré dans le domaine, de même que par les projets menés par des institutions comme la Bibliothèque publique de Toronto, Bibliothèque et Archives Canada et Bibliothèque et Archives nationales du Québec. Les initiatives de l'Institut canadien de microreproductions historiques et les projets subventionnés, comme les Annotated Bibliographies of Canada's Major Authors (ECW Press), ont également contribué à l'avancement des connaissances. L'accès aux sources primaires pour les chercheurs a ainsi été grandement amélioré.

Deuxièmement, le champ de recherche sur la bibliographie matérielle, dont les origines remontent au début du XX^e siècle avec les travaux pionniers de McKerrow, Greg et Bowers, a exercé une large influence en Grande-Bretagne, en Amérique du Nord et en Australie. Les *Principles of Bibliographical Description* de Bowers ont d'ailleurs servi de fondement aux études supérieures en anglais pendant trois décennies. Au tournant des années 1980, les travaux innovateurs de Robert Darnton et de D. F. McKenzie ont permis d'élargir le champ de recherche de la bibliographie matérielle en interrogeant la prépondérance accordée à la matérialité de l'objet livre. Au même moment, la discipline émergente de l'histoire du livre et les grands projets nationaux d'histoire du livre (en France, notamment), en mettant l'accent sur l'étude des auteurs, de l'édition et de la lecture, se sont éloignés des questions relatives à la bibliographie matérielle. C'est à la lumière de ces changements que la Société bibliographique du Canada a revu son rôle et sa mission et qu'elle s'est ajustée à l'évolution des recherches en histoire du livre et de l'imprimé.

Finalement, parallèlement à l'essor de l'histoire du livre et au déclin de la bibliographie matérielle, l'apparition du réseau Internet, la numérisation de documents et l'arrivée de l'hypertexte ont entraîné des changements importants touchant la diffusion de sources primaires et la production de bibliographies, qu'on peut maintenant réaliser sous forme électronique. Des projets comme Early Canadiana Online, Early English Books Online et NINES montrent bien l'évolution de ces nouveaux modes de communication. Ainsi, et alors que le projet *Histoire du livre et de l'imprimé au Canada* touche à sa fin, avec la parution prochaine du troisième et dernier volume, de nouvelles interrogations voient le jour eu égard aux possibilités nouvelles et quasi infinies de la numérisation.

À l'occasion du quatrième colloque national sur la bibliographie canadienne, la Société bibliographique du Canada a donc choisi d'explorer le thème suivant : la bibliographie à l'ère du numérique. Grâce au soutien financier et à la collaboration de Bibliothèque et Archives nationales du Québec (BAnQ), le colloque se tiendra à Montréal, dans les locaux de la Grande Bibliothèque de BAnQ, du 20 au 22 juin 2007.

Le comité organisateur du colloque souhaite recevoir des propositions de communications portant sur les thèmes suivants :

- l'impact du numérique sur les pratiques bibliographiques traditionnelles;
- les recherches croisées en bibliographie matérielle et en histoire du livre et de la culture de l'imprimé (exemples théoriques et pratiques);
- la normalisation des métadonnées et la place de la bibliographie matérielle dans les programmes d'étude.

Les chercheurs spécialisés en bibliographie matérielle canadienne, en histoire du livre ou ayant développé des connaissances sur la numérisation du patrimoine imprimé sont invités à soumettre une proposition de communication. Les travaux de jeunes chercheurs sont également attendus avec grand intérêt.

Our 2007 conference will be quite different in character, purpose, and scope from the BSC's usual annual conferences. The 4th national conference on Canadian bibliography will follow in the footsteps of the conferences in Vancouver 1974, Halifax 1981, and Charlottetown 1992 which reviewed how bibliography was conducted in Canada in various disciplines and at the national, provincial, regional, and local levels. These conferences also provided an important forum for brain-storming among scholars for future work, new developments and programmes, and new interdisciplinary relationships. The 4th conference will examine the current state of bibliography, but will also explore some of the changes and challenges that confront us, as a discipline, as a Society, and as individual practitioners and scholars.

Since the 3rd conference, bibliography has expanded its traditional focus and has branched out into the burgeoning field of the history of the book, which includes the socio-cultural aspects of book production, authorship, textual studies, reception, critical editing, and reading practices. The phenomenon of hypertext, digital facsimiles, and the internet has had enormous impact on the accessibility of electronic renderings of primary texts, the production of bibliographies, and the study of book history. The 4th conference will address some of these developments. Previous national conferences have had profound impacts on bibliographical activity in Canada in a number of ways: on funding, in generating new initiatives at national institutions and organizations, and on scholarly work and teaching at universities and elsewhere. We expect a similar impact as a result of the 2007 conference.

Entitled **Beyond the Text: Bibliography in the Digital Age**, the conference will take place 20-22 June 2007 in Montréal. The host institution is la Grande Bibliothèque, a state-of-the-art facility opened in 2005 by Bibliothèque et Archives nationales du Québec. The BSC will also work with Library and Archives Canada and the Bibliographical Society of America (BSA). The conference will feature a combination of invited speakers and submissions chosen from the responses to the Call for Papers. A number of key presentations have already been confirmed, including opening remarks by Lise Bissonnette, Présidente-directrice générale de la Bibliothèque nationale du Québec; a panel on the achievements and legacy of the *History of the Book in Canada* project; and a joint session with the BSA exploring the challenges facing bibliographical societies.

Toronto Centre for the Book Lecture Series - Reports

The Toronto Centre for the Book (www.library.utoronto.ca/tcb) was established in 1994 at the University of Toronto to bring together faculty, librarians, students, and members of the general public interested in the past, present, and future of the book and in all aspects of the creation, diffusion, and reception of the written word. Each year it presents a series of lectures on aspects of the book. At the invitation of Shelley Beal and Pat Belier, students in the Books 1000 course, the core course in the Collaborative Program in Book History and Book Culture at the University of Toronto, are writing summaries of the lectures they have attended.

•“Reading Writing Surfaces: Jane Austen’s Fiction Manuscripts”



Kathryn Sutherland (University of Oxford)

Is it possible that author Jane Austen had different intentions for the venerable Mr. Darcy than what was printed? That was the question raised by Oxford professor Kathryn Sutherland in her lecture given on 29 September 2006.

In her examination of the available Austen manuscripts, Professor Sutherland discovered that the author’s work had been altered - sometimes significantly - before being printed. These changes were often made by her publishers, who added such grammatical and layout devices as speech

quotations and paragraph indentations. Sutherland used the example of *Persuasion*, showing the changes from manuscript to final printed text.

Book historians are still learning how to read and decode Austen's texts as the working manuscripts tell a different story and rely on a different series of events than what was presented to the general public. Austen had expressed unease with the final printed text, telling the publisher that the character voices were wrong. Sutherland argued that as book historians we need to look at these texts with a critical eye in order to fully understand the uniqueness and original intent of Austen's work and she suggested that Austen's original manuscripts be made available in order to fully understand the original intent and nuances of her characters. -- **Review by Lindsay M. individual ships and entire fleets. Curiously, however, the work lacks technical detail and contains errors in many places. McGee contended the work was not an instructional manual or a personal aid but an exhibition of his seasoned mariner's knowledge to the nobles, merchants, and important citizens of Venice. The highest posts in the Venetian fleet were won in highly contested elections and the manuscript was created to set Michael above similarly experienced Venetian citizens. The expense of such an undertaking illustrates the life-long zeal of a foreign commoner to insert himself into the highest positions of Venetian society.

Those attending were amazed by the excellent condition of the manuscript, save for the final, well-worn, page. Containing Michael's illustration of St. Christopher bearing the Baby Jesus, it was often touched, for luck, on the author's long voyages around the known world. -- **Review by Steven Chabot**



In a lecture given on 20 October 2006, David McGee discussed the manuscript of Michael of Rhodes, providing a unique look into the intellectual life of a 15th-century commoner. Lost for 400 years, the manuscript is the life experience of a common mariner who worked his way up through the ranks from oarsman to the highest non-noble post in the Venetian fleet. And, in turn, Michael's life explains some anomalies about the manuscript itself.

Filled with mathematical problems, tables of calendar dates, navigational calculations and ship schematics, the book contains much of the knowledge required to outfit and direct both

Douglas Maitland Gibson was born in 1943 in Kilmarnock, Scotland. He gained an MA at the University of St. Andrews. After acquiring a further MA at Yale, he came to Canada in 1967 and entered the world of publishing in March 1968 as an editor at Doubleday, Canada. He joined Macmillan of Canada as Editorial Director in 1974 and became publisher in 1979. In 1986 he joined McClelland & Stewart as editor and publisher of a new line of books under his own imprint. Since then, Douglas Gibson Books has published works by authors such as Alice Munro, Jack Hodgins, and W.O. Mitchell. In 1988 Gibson became publisher of McClelland & Stewart, attracting to the house old colleagues like Robertson Davies, Michele Landsberg, and Guy Vanderhaeghe. He was the president and publisher of M&S from 2000 until 2004. In 2004 he returned to publishing under his own imprint at M&S.
