A message from the President

This year has been a successful one for our Society. Thanks to the generosity of our members, the ratification of the fees increase at the 2008 AGM and the excellent work of our Treasurer, Tom Vincent, we are able to carry on our work, including our publications program. About fifty of our members attended the SHARP conference in Toronto where the Society sponsored a very well-received bibliography workshop, with sessions given by Patricia Fleming, Sandra Alston, Carl Spadoni, Judy Donnelly and Eli MacLaren. Many members were able to attend a dinner at the University of Toronto Faculty Club to celebrate the presentation of the Tremaine medal to George Parker. During our AGM, prizes were awarded to the three winners of the first National Book Collecting Contest. BSC Council member John Meier organized the contest, and we are grateful to him and to our fellow sponsors, the Antiquarian Booksellers Association of Canada, the Alcuin Society, and Hemlock Printing, as well as to the judges, for making this first contest a great success.

In 2010 we will meet with the Congress of the Humanities and Social Sciences which is being held in Montréal - the BSC session dates are May 31st to June 1st 2010. This year's Congress theme is "Connected Understanding / *Le savoir branché*." I am happy to report that we are again collaborating with the Canadian Association for the Study of Book Culture (CASBC/ACÉHL) and have arranged for a joint day of sessions with them on May 31st. In addition to working with CASBC we are also collaborating with the Association of Canadian College and University Teachers of English (ACCUTE), and with the Association québécoise pour l'étude de l'imprimé (AQÉI) on shared sessions. The ACCUTE session is a member-organized session by Eli MacLaren, which will be part of the BSC/CASBC shared day. The Call for Papers for that session and for the BSC program on June 1st is available on the BSC website, and the deadline for submissions is 4 January 2010. The first day will end with a plenary speaker, Claude La Charité, who is an Associate Professor at the Université du Québec à Rimouski and holds the Canada Research Chair in Literary History, followed by a reception. On June 1st, Marie-Pier Luneau has organized a two-hour panel for the AQÉI session, entitled "Ouvriers de l'ombre : trajectoires méconnues de l'histoire du livre au Québec", with presentations by Josée Vincent (UdeS), Frédéric Brisson (UdeS), Marcel Lajeunesse (U de Montréal) et Éric Leroux (U de Montréal), which will be chaired by Paul Aubin.

Our own members will have a chance to meet and socialize on the first day at a members-only continental breakfast before the program sessions start. We also hope to have a reception for BSC members on the afternoon of June 1st, following the final session of papers. The Annual General Meeting will be held over the lunch period on June 1st. More information will be available on the BSC and Congress websites, as plans are finalized. www.congress2010.ca/

Many people have expressed concern about some of the changes taking place at Library and Archives Canada / *Bibliothèque et Archives Canada* and I sent a letter on behalf of the membership to Daniel Caron, which was published in the spring 2009 *Bulletin*. LAC/BAC has now issued an announcement regarding their review of acquisitions policies, with links to supplementary documents on their Documentary Heritage Management Framework, which can be found on the BSC/SbC site, in the news section of our English and French webpages (see also page 5 in this issue). Evidently, preparations are well underway to move the rare book collection to Gatineau from its present Wellington Street location, which will not only be inconvenient for researchers, but may also prove harmful to the collection itself. LAC/BAC is asking for input from stakeholders and I encourage people to take advantage of this opportunity to make your concerns heard.



Un message de la présidente

La SbC a connu une excellente année. Grâce à la générosité de nos membres, à la ratification d'une augmentation des frais d'adhésion lors de l'AGA de 2008 et aux efforts admirables de notre trésorier, M. Tom Vincent, nous pouvons poursuivre notre travail et maintenir notre programme de publications. Environ cinquante membres ont participé à la conférence SHARP, qui a eu lieu à Toronto; la SbC y commanditait un atelier de bibliographie fort apprécié, comptant des séances dirigées par Patricia Fleming, Sandra Alston, Carl Spadoni, Judy Donnelly et Eli MacLaren. Plusieurs membres furent également présents à un dîner tenu à au University of Toronto Faculty Club, où la médaille Tremaine a été décernée à M. George Parker. Lors de l'AGA, des prix ont été remis aux trois gagnants du premier Concours national de collections de livres. M. John Meier, membre du conseil de la SbC, a pris en charge l'organisation de ce concours et nous souhaitons lui exprimer notre reconnaissance, ainsi qu'à nos commanditaires, l'Association de la librairie ancienne du Canada, la Société Alcuin et Hemlock Printing. Nous remercions également les juges, qui ont contribué au succès de ce projet.

En 2010 nous nous joindrons au Congrès des sciences humaines et sociales qui aura lieu à Montréal – les séances de la SbC se tiendront le 31 mai et le 1 juin 2010. Le thème de ce congrès sera “*Connected Understanding / Le savoir branché.*” J'ai le plaisir d'annoncer que nous prévoyons collaborer à nouveau avec l'Association canadienne des études en histoire du livre (*CASBC/ACÉHL*) et que nous organisons avec eux une séance qui aura lieu le 31 mai. En plus de notre collaboration avec l'ACÉHL, nous tiendrons des séances partagées avec la *Association of Canadian College and University Teachers of English (ACCUTE)* et à l'Association québécoise pour l'étude de l'imprimé (*AQÉI*). La séance d'*ACCUTE* sera organisée par Eli MacLaren, membre de la SbC, et comptera parmi les activités organisées lors de la journée d'échanges scientifiques partagée par la SbC et l'ACÉHL. L'appel de communications pour cette séance et pour le programme de la SbC du 1 juin est maintenant disponible sur le site Web de la SbC; veuillez noter que la date limite est le 4 janvier 2010. La première journée se terminera par la communication du conférencier invité, M. Claude La Charité, professeur à l'Université du Québec à Rimouski et titulaire de la Chaire de recherche en histoire littéraire. Marie-Pier Luneau a ensuite organisé pour le 1 juin la séance de l'*AQÉI* qui sera intitulée « Ouvriers de l'ombre : trajectoires méconnues de l'histoire du livre au Québec ». Cette séance de deux heures, présidée par M. Paul Aubin, comptera parmi ses conférenciers Josée Vincent (UdeS), Frédéric Brisson (UdeS), Marcel Lajeunesse (U. de Montréal) et Éric Leroux (U. de Montréal).

Nos membres auront la chance de se rencontrer et de causer lors d'un déjeuner continental qui aura lieu la première journée des conférences avant le début des séances. Nous espérons également organiser une réception pour les membres de la SbC suivant les dernières séances du 1 juin, en après-midi. L'AGA aura lieu sur l'heure du dîner le 1 juin. Plus de renseignements seront disponibles sur les sites Web de la SbC et du Congrès lorsque l'organisation de ces deux journées sera terminée. www.congress2010.ca/

Plusieurs individus ont exprimé leur inquiétude à la suite des changements qui s'opèrent à *Library and Archives Canada / Bibliothèque et Archives Canada*; j'ai fait parvenir une lettre au nom des membres de la SbC à M. Daniel Caron (publiée dans le *Bulletin* de printemps 2009). *LAC/BAC* a maintenant annoncé ses révisions des politiques d'acquisitions et propose des liens vers des documents supplémentaires sur le Cadre de gestion du patrimoine documentaire, qui se trouve sur le site Web de la *BSC/SbC*, dans la section “Nouvelles” (voir la page 6 dans ce numéro). Évidemment, les préparations pour le déménagement de la collection de livres rares de leur lieu de conservation sur la rue Wellington, à Ottawa, vers Gatineau sont déjà en cours; ce changement de lieu de conservation s'avérera non seulement incommodant pour les chercheurs, mais pourrait également nuire à la collection elle-même. *LAC/BAC* demande l'avis des parties prenantes et je vous encourage à profiter de cette opportunité pour faire connaître votre opinion.

Library and Archives Canada. Message to Stakeholders - Acquisitions

In May 2009, Library and Archives Canada (LAC) wrote to inform you of a short-term moratorium on purchased acquisitions. Then, in August 2009, we sent another message to advise you that we are in the process of reviewing our approach to the management of Canada's documentary heritage in order to better meet the needs of today's society and to remain relevant, trusted, and valued by the Canadian public.

As you know, the information environment has been profoundly transformed with new forms of digital information that challenge all memory institutions to adapt what and how they collect. Due to the overwhelming digital production and the use of social technologies by organizations and individuals, new expectations among users have arisen. That said, LAC must ensure that the documentary heritage the institution acquires and preserves today, whether it is rare books, electronic publications or other essential materials, truly contributes in providing the most accurate picture of Canadian life and that its content is of value to Canadian society in the future.

Therefore, over the past few months, we have been developing a Documentary Heritage Management Framework (DHMF) based on three pillars of documentary heritage: acquisition, preservation and resource discovery. The DHMF will be based on four guiding principles designed to assess the value of acquisitions: Significance, Sufficiency, Sustainability, and Society and on key roles: foundation building, collaboration, program, and transfer.

A preliminary Acquisition Orientation Instrument was developed, to guide our decision making by using standardized criteria and understandings. The purpose of this instrument is to institute a systematic approach to the professional justification of the acquisitions of documentary heritage. At the same time, the intent is to be open to new approaches with other memory institutions. The feedback we have received to date from our stakeholders were factored into the Acquisition Orientation Instrument.

We invite you to consult the Documentary Heritage Management Framework and the Acquisitions Orientation discussion documents at www.collectionscanada.gc.ca and encourage you to provide feedback and comments. Stakeholder consultations are being prepared and your input is needed to further develop this acquisitions approach. Also, please consider either making a link to our website or posting the contents of our discussion documents on your website.

As part of the ongoing exercise of considering new approaches to the management of Canada's documentary heritage and evaluating the way acquisitions are carried out at LAC, we implemented a short-term moratorium, which will be lifted, effective January 30, 2010. This is allowing us the time to evaluate business practices within LAC's collections and to fine-tune and prepare the implementation of the new Framework and Orientation.

We would like to thank you for your collaboration during this phase of modernization. LAC values the relationship it has established over the years with you, our stakeholders, clients and suppliers, in providing the most accurate representation of Canadian life for the benefit of present and future generations.

Bibliothèque et Archives Canada. Message aux parties intéressées - acquisitions

En mai 2009, Bibliothèque et Archives Canada (BAC) vous a écrit pour vous aviser de l'adoption d'un moratoire temporaire sur nos acquisitions effectuées par le biais d'achats. Puis, en août 2009, nous vous avons écrit à nouveau pour vous informer que nous procédions à une révision de notre approche de la gestion du patrimoine documentaire du Canada afin de mieux répondre aux besoins de la société d'aujourd'hui et de nous assurer que BAC demeure pertinent, digne de confiance et important pour le public canadien.

Comme vous le savez, les nouvelles formes que prend l'information numérique ont profondément transformé l'environnement de l'information et obligent toutes les institutions de mémoire à adapter leurs procédures en matière d'acquisition. L'abondance de la production numérique et l'utilisation des technologies sociales par les organismes et les individus ont créé de nouvelles attentes parmi les utilisateurs. Cela étant dit, BAC doit veiller à ce que le patrimoine documentaire acquis et préservé aujourd'hui, qu'il s'agisse de livres rares, de publications électroniques ou d'autres matériels essentiels, concoure véritablement à dresser un portrait le plus fidèle possible de la vie canadienne et à ce que son contenu ait de la valeur pour la société canadienne dans le futur.

Ainsi, depuis quelques mois, nous travaillons au développement d'un Cadre de gestion du patrimoine documentaire (CGPD) fondé sur trois piliers du patrimoine documentaire : l'acquisition, la préservation et l'exploration des ressources. Le CGPD reposera sur quatre principes directeurs conçus pour déterminer la valeur des acquisitions : l'importance, la suffisance, la viabilité et la société, et sur des rôles clés : le réseautage, la collaboration, le programme et le transfert.

Un outil d'orientation préliminaire en matière d'acquisition a été produit pour guider nos décisions en fonction de critères normalisés et d'une compréhension commune. Son but est d'instituer une approche systématique et professionnelle pour justifier l'acquisition de documents du patrimoine. Nous cherchons aussi à nous ouvrir à de nouvelles approches de concert avec d'autres institutions de mémoire. Les commentaires reçus à ce jour de nos parties intéressées ont été pris en compte dans l'élaboration de cet outil d'orientation en matière d'acquisition.

Nous vous invitons à consulter le Cadre de gestion du patrimoine documentaire et l'outil d'orientation en matière d'acquisition au www.collectionscanada.gc.ca et à nous faire part de vos commentaires et réactions. Nous préparons actuellement une série de consultations avec les diverses parties intéressées et vos commentaires nous aideront à développer notre nouvelle approche en matière d'acquisition. Aussi, veuillez considérer la possibilité de créer un lien vers notre site Web ou d'afficher nos documents de discussion sur votre site Web.

Dans le cadre de cet exercice continual visant à examiner de nouvelles approches pour la gestion du patrimoine documentaire du Canada et à évaluer les procédures d'acquisition de BAC, nous avons mis de l'avant un moratoire temporaire, lequel sera levé le 30 janvier 2010. Ceci nous donnera le temps d'évaluer les pratiques opérationnelles quant aux collections de BAC et de peaufiner et préparer la mise en œuvre du nouveau cadre de gestion et du nouvel outil d'orientation.

Nous tenons à vous remercier de votre collaboration durant cette phase de modernisation de BAC. La relation que nous avons établie au fil des années avec vous, nos partenaires, clients et fournisseurs, pour fournir une représentation la plus fidèle possible de la vie canadienne aux générations présentes et futures nous tient à cœur.

Annual Conference - 2010 Congress of the Humanities and Social Sciences, Concordia University, Montréal, 31 May - 1 June 2010

Call for Papers: “*The Materiality of Texts*”

There is more to a text than meets the casual reader’s eye. The specific forms in which it is received govern its significance, which we cannot fully grasp without enumerating and explaining these forms. An eighteenth-century novel reflects the class for whose consumption it was created; a twentieth-century novel foresees its own adaptation to film; a twenty-first century novel enshrines the ideology of the granting council that funded it. The “materiality of texts” is one label for the shaping impact of social and economic factors on language and literature, and it has emerged as a major point of convergence in literary studies, bibliography, and post-Marxist theory.

Papers are invited on any aspect of the materiality of texts, such as:

- **The monied text and the players:** Incentive, rewards, careers, publication, performance, exchange—what are the human motivations behind textual production?
- **The mirror and the private reader:** Far from critical hierarchies, individuals turn to texts of all sorts and discover themselves. What and how can we learn about the value of texts to specific readers other than ourselves?
- **The fluid text and the scholarly editor:** How do variants affect the significance of a work? How should one represent and organize the different incarnations of a text?
- **Intersections in method:** Bibliography and cultural studies both take the “materiality of texts” as a starting point but trace noticeably different trajectories. How might these different fields of contemporary scholarship fruitfully learn from one another?

Submissions, in English or French, should be sent to Eli MacLaren (eli.maclaren@gmail.com) by 4 January 2010 and should include the following:

- A proposal (max. 700 words) or a complete paper (max. 8-10 pp. double-spaced)
- An information sheet including: name, professional designation (professor, doctoral candidate, etc.), institutional affiliation, e-mail address, abstract (100 words), bio (50 words), A/V requirements (if any)

Please note that submissions will be considered for a joint session with the Canadian Association for the Study of Book Culture (CASBC) on 31 May 2010 as well as for the BSC sessions on 1 June 2010. All presenters and attendees must be registered at the Congress, but it is not necessary for presenters to be members of the BSC.

Conférence annuelle du Congrès des sciences humaines 2010, Université Concordia, Montréal, 31 mai - 1^{er} juin 2010

Appel de présentations : « **Le texte, chose concrète et objet de consommation** »

Il n'y a pas que le texte qui s'impose à l'attention du lecteur occasionnel. La forme physique de son support, le livre, ainsi que les facteurs socioéconomiques qui l'ont rendu possible, déterminent aussi sa signification, de telle sorte que ces considérations doivent être prises en compte si l'on veut aborder pleinement la question. 
The view that early modernity saw the transformation of European societies into cultures of print has been widely influential in literary, historical, philosophical, and bibliographical studies of the period.

The concept of print culture has provided scholars with a powerful tool for analyzing and theorizing new (or seemingly new) regimens of knowledge and networks of information transmission as well as developments in the worlds of literature, theatre, music, and the visual arts. However, more recently the concept has been re-examined and destabilized, as critics have pointed out the continuing existence of cultures of manuscript, queried the privileging of technological advances over other cultural forces, and identified the presence of many of the supposed innovations of print in pre-print societies.
