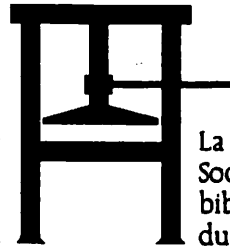

### ANNUAL MEETING, JUNE 1984

### MINUTES OF THE 1983 ANNUAL MEETING OF THE SOCIETY

The thirty-eighth Annual Meeting of the Bibliographical Society of Canada/La Société bibliographique du Canada was held on Wednesday, June 15, 1983, in Winnipeg, Manitoba. A programme on the theme "Bibliography in Western Canada" had been organized by the President, Miss Liana Van der Bellen, and the local arrangements committee composed of Joyce Irvine, Librarian of the Legislative Library of Manitoba, Leslie Castling also of the Legislative Library, and Ruth May of the University of Manitoba Library. The President chaired the morning and the afternoon sessions held in the Manitoba Legislative Building. The following papers were presented; in the morning:

"Agriculture in Manitoba: a Selected Bibliography" - Judy Harper, Head, Agriculture Library, University of Manitoba;  
"Hudson's Bay Company Printing in the Reign of Queen Anne" - Dr. H.C. Wolfart, Professor of Linguistics, University of Manitoba;  
"The Printing of the Cree Bible" - Joyce Banks, Rare Books and Conservation Librarian, National Library of Canada;

in the afternoon:

"Selkirk Papers Publication Project" - Dr. J.M. Bumstead, Professor of History, University of Manitoba;  
"Où peut mener la passion pour la recherche?" - Dr. Annette Saint-Pierre, Directrice, Centre d'études franco-canadiennes de l'Ouest.

The 38th annual business meeting followed the afternoon session at 4:00 p.m. The President, Miss Liana Van der Bellen, called the meeting to order and welcomed the thirty members and guests present. Approval of the agenda was moved by Ms. Beth Miller, seconded by Dr. Olga Bishop, and carried.

The first item of business was the presentation of the Tremaine Medal for distinguished service to Canadian Bibliography to Dr. Alan F.J. Artibise, Director of the Institute of Urban Studies, University of Winnipeg. Mr. David Kotin read the citation, and the President presented the medal on behalf of the members of the Society. In response Dr. Artibise spoke of the importance of cooperation between bibliographers and the dependence of each bibliographer on the work of other bibliographers, and voiced his appreciation of the assistance he had received from the University of British Columbia Press. He thanked the Society for its recognition by honouring him with this award.

The minutes of the thirty-seventh annual meeting having been published in the May 1983 issue of the Bulletin, the secretary, Miss Eleanor Magee, moved their adoption as printed, seconded by Dr. W.J. Cameron. The motion was carried.

Miss Van der Bellen then presented her President's report. She emphasized the Society's need for more members, in particular the need for better regional representation for areas other than Ontario. She then reported on the Council's action, as provided for in the Constitution, in appointing an interim Secretary-Treasurer, Miss Eleanor E. Magee, to replace Miss Marion Cameron who had resigned the position as of December 31, 1982. She also reported on the achievement of the status of a registered charitable organization for the Society, retroactive to May 1, 1982, pointing out that the Society could now accept donations and issue receipts for income tax purposes for these gifts. She reported further that guidelines for holding of annual meetings have been developed by Ms. Beth Miller and Mr. W.F.E. Morley, and that Council had accepted these guidelines with the intent of implementing them as soon as possible. She reported that she had been asked by the Chairman of the Parliamentary Standing Committee on Communications and Culture for the Society's comments of the Applebaum-Hebert Report, but because of the very short time allowed for preparing this response, she has responded by giving her own views as President, recommending continued support for libraries and archives and the Social Sciences and Humanities Research Council.

As Treasurer, Miss Magee distributed the annual financial report prepared by the past Treasurer, Miss Cameron, and asked for questions. She pointed out that the report covered a short financial year from April 30, 1982, to December 31, 1982, because of the decision to change the financial year to coincide with the calendar year. As of December 31, 1982, the balance in the General Account was \$9,145.26, and in the Bibliography of Canadian Bibliographies account \$4,364.58. Her motion for the adoption of the report was seconded by Professor Artibise and carried.

In the absence of the Chairman of the Nominating Committee, Dr. Robert C. Brandeis, Ms. Beth Miller presented the slate of officers for the 1983-1984 as follows:

The President called for further nominations from the floor. There being none, Ms. Beth Miller moved the acceptance of the report, seconded by Professor Gayle Garlock. The motion was carried. The President thanked retiring Council members for their work and then introduced the new councillors present.

Professor Peter McNally pointed out the need for maintaining a good relationship with members and suggested that a greater involvement of members might be obtained by seeking names for nominations to Council by notices in the Bulletin. His motion that members be solicited in the spring and fall Bulletins to nominate members for the Council and Executive was seconded by Dr. Robert Brandeis and carried.

A report on the activities of the Publications Committee was given by the President in the absence of the Chairman, Mr. Bruce Peel. He reported that a new publications policy was being developed and that the Committee had taken on, as well, the responsibility for the progress of the third edition of the Bibliography of Canadian Bibliographies.

In the absence of the Editor of the Papers/Cahiers, Miss Elizabeth Hulse, the President reported on the progress of volume XXI (1982), which was expected to be issued in the early fall, and on the decision to prepare a consolidated index to the first twenty volumes for publication in 1984, funds permitting. The President then reported the resignation of Miss Hulse as Editor, after having held that position for five years. Dr. Gayle Garlock moved a vote of

thanks to Miss Hulse for her fine work as Editor on behalf of the Society. The motion, seconded by Mr. David Kotin, was carried. The President then welcomed the new Editor, Ms. Patricia Stone and introduced her to the members.

The Bulletin Editor, Ms. Beth Miller, reported that numbers 19 and 20 of the Bulletin had been issued, as well as a Directory of Members to 31st March 1983. She also pointed out that postage rates had greatly increased and suggested measures for decreasing these costs. Her motion for the adoption of her report was seconded by Dr. Michel Thériault and carried.

In the absence of Professor Douglas Lochhead, the President reported on the CBISSSH, stating that its main preoccupation at the present time appeared to be the proposal for a clearing house for bibliographic projects at the National Library and that it had held no meetings since the fall of 1982. She also noted that Professor Lochhead would be resigning as representative because of his absence from Canada after September 1, 1983, but that he would be replaced only when the Committee asked for a replacement.

Mr. Richard Landon, reporting on the ESTC, noted that Canadian holdings were well represented in the ESTC, but urged those libraries with holdings not included there to begin reporting their holdings.

The Review Editor of the Papers/Cahiers, Mr. David Kotin, spoke of his difficulty in finding reviewers who would be punctual in sending in their reviews and asked that persons interested in being reviewers volunteer their assistance.

In response to a question from the floor, the President reported she had not received a report from the Editor of the Bibliography of Canadian Bibliographies, but noted that she had mentioned the involvement of the Publications Committee earlier.

The members then turned to the matters of the appointment of an auditor, and the place of the 1984 meeting. On motion from the Treasurer, Miss Magee, seconded by Dr. Michel Thériault, the appointment of an auditor, Miss Linda Lauzon, London, Ontario, in accordance with the provision in the Constitution was approved. The President then reported that the thirty-ninth Annual Meeting would be held in Toronto in June 1984 in conjunction with the Canadian Library Association Conference, and that Toronto would be celebrating its 150th anniversary in that year. She noted that the possibility of meeting with the learned societies had been considered, but no decision reached. She asked that members with strong views for or against this change send their views to Council.

She then reported the death of a member of the Society, Mrs. Josephine Giesbrecht.

A vote of thanks was moved to the Winnipeg organizers and hosts for a pleasurable and informative meeting. The meeting ended at 5 p.m. on a motion of adjournment. The members and guests then gathered in a lounge for a reception with refreshments and conversation.

#### GRUPE DE RECHERCHE EN HISTOIRE DE L'IMPRIME AU QUEBEC (GRHIQ)

A meeting of the Groupe de recherche en histoire de l'imprimé au Québec was held Friday, March 30, 1984 at the National Library of Canada in Ottawa. Liana Van der Bellen and Dr. Michel Theriault were convenors. At the request of Professor Yvan Lamonde, Director of the centre d'études canadiennes françaises McGill University, the papers presented at the meeting dealt with the history of printing, publishing, the book trade and libraries in areas outside Québec. Four speakers discussed their research in the following fields:  
"Upper Canada Imprints, 1801-1841," Dr. Patricia Fleming, Professor, Faculty of Library and Information Science, University of Toronto; "Toronto Printers, Publishers, Booksellers and the Allied Trades, 1798-1900," Miss Elizabeth Hulse, Thomas Fisher Rare Book Library, University of Toronto; "Review of Recent English-Canadian Literature on Library History," Professor Peter McNally, Graduate School of Library Science, McGill University; and "Book Trade in Canada, 1750-1900," Dr. George Parker, Royal Military College, Kingston, Ontario.

About thirty participants were present, many from academic institutions and libraries such as Carleton University, McGill University, University of Toronto, University of Alberta, University of Calgary, the University of Ottawa, Trent University, the University of Western Ontario, La Bibliothèque nationale du Québec, La Bibliothèque de la Législature Québec; the North York Public Library, the National Library of Canada, the Public Archives, the Department of National Defense Library, the Museum of Science and Technology, the Canadian Institute for Historical Microreproduction.

An important part of the session was the opportunity for participants to report on their research projects.

After editing JEngL since he founded it in 1967, R.A. Peters has now stepped down in order to pursue other interests. Beginning with Vol. 17 (1984) JEngL's new editors will strive to maintain the high standard Peters has set in publishing articles and reviews of books on "the modern and historical periods of the English language." The journal will, however, have a new look with computer typesetting, a new balance between historical and modern articles and reviews, and a new emphasis on coverage of scholarship on English conducted outside North America.

The new editors would like to invite submission of articles appropriate to the mission of the journal. In the past JEngL has published work on subjects ranging from Old and Middle English to modern English grammar and American dialectology. The new editors will consider both synchronic and diachronic studies, prepared according to either traditional or neolinguistic methods. Articles normally have ranged from 10-25 pages in typescript. All submissions should conform to general standards of scholarly writing; either MLA or LSA style is acceptable. Notes and references should be typed separately and placed at the end of the article. Please submit the original typescript and one photocopy, and include a self-addressed envelope with sufficient postage to allow return of the MS. All submissions will be juried and the decision rendered within 90 days of submission; all decisions will be accompanied by a summary of readers' comments. Unsolicited reviews cannot be accepted for publication.

JEngL has an international readership. and is published in an annual volume of one number. All articles and reviews are published in English. The subscription rate for Vol. 17 will be \$7 (US) for all subscribers. whether individual or institutional; back issues. when available. are also priced at \$7 (US) until publication of Vol. 17.
