2. Amendments to the Constitution

At its Spring meeting the BSC council unanimously passed motions to place the following changes to the Constitution and By-laws of the Society before the membership at the next Annual Meeting, June 3, 1991:

1. That the positions and functions of Secretary and Treasurer should be fully separated for clarity. Thus, wherever the By-laws at present state "Secretary (-Treasurer)", they should state "Secretary"; and similarly, wherever they at present state "(Secretary-) Treasurer". they should state "Treasurer".
2. That the wording of By-law 2.e be replaced with the following:

The Treasurer shall present detailed financial statements for the preceding year to the Council at its meeting next before the Annual Meeting and to the members at that Annual Meeting. Such statements, with the documentation relevant to them, shall have been previously under a review engagement by a qualified public accountant outside the Council, who is appointed by the Council.

Members are reminded that a notice of a fees increase was published in the Fall Bulletin and will be voted upon at the Annual Meeting.

3. Minutes of the 1990 Annual Meeting

The forty-fifth Annual Meeting of the Bibliographical Society of Canada/Société bibliographique du Canada was held on Monday, May 21, 1990 at the Cornett Building, University of Victoria, Victoria, B.C.

1. Programme:

The President, Ernest Ingles, welcomed the members, speakers and guests present. He announced that the Tremaine Medal presentation to the noted history professor of Laval University, Claude Galarneau will take place on June 14th at the time of the joint meeting of the Bibliographical Society and the CLA Special Collections Interest Group in Ottawa. Prof. Galarneau was unable to come to Victoria.

The Convener of the Annual Meeting, 1st Vice-President Sandra Alston chaired the morning session, Joanne Henning, Council member, chaired the afternoon session. About 25 members were present.

II. Annual Meeting:

The business portion of the Annual Meeting followed the afternoon session at 4:00p.m., with the President, Ernest Ingles in the Chair.

1. The Agenda was adopted as distributed.
2. The Minutes of the forty-fourth Annual Meeting had been published in the May 1990 Bulletin (New Series, No. 34) and circulated to members. Adoption of the Minutes was moved by S. Alston, seconded by A. Steele. CARRIED.
3. Report of the President:

The President expressed his thanks to the Convener, Sandra Alson and the local arrangements Chair, Marnie Swanson. He then reported on a number of issues:

- i) Three Council members have resigned and will have to be replaced: Rhys Williams (Treasurer), Marilyn Flitton (Indexer), Yvan Lamonde (Book Review Editor, French language reviews). The President thanked them in the name of the Society for their years of dedicated work.
- ii) Membership: 100 new members have joined in the Society in the past two years. Recruitment has been carried out by contacting researchers working the field of bibliography and SSHRCC grant recipients. The brochure has been revised and sent to pertinent associations and journals. A new membership list was distributed. A survey of members field of interest was done on the basis of a questionnaire devised by P. Fleming and S. Alston. The Council will discuss the question of a possible increase of membership fees at the fall meeting.
- iii) Work on the third edition of the Bibliography of Canadian Bibliographies is progressing on schedule. The Editorial Board composed of P. Fleming, B. MacDonald, D. Kotin, E. Ingles, M. Bond, R. Hopkins and D. Lochhead (Honourary member) has held meetings. Gordon Adshead has been hired as researcher.

- iv) Work on the supplement to Tremaine's Bibliography of Canadian Imprints, 1751-1800 is progressing also. P. Fleming and S. Alston have recorded over 100 items "not in Tremaine" as well as many items Tremaine listed but did not locate or examine.
- v) The Tremaine Fellowship (\$1000) was awarded to Ruth Panofsky PhD candidate in English Literature at York University, to pursue bibliographical research on Thomas Chandler Haliburton.
- vi) The long-time Secretary-Treasurer of the Society (1955-1979), Mrs. R. C. (Esther) Jacobsen has been named Honourary Member.
- vii) The Council has discussed the possibility of organizing a major conference in 1992 on the state of Canadian bibliography, to be sponsored jointly by the BSC, the National Library and perhaps the Association for Canadian Studies. The conference would present an overview of bibliographic work done since 1981, and would be a follow-up to the two previous conferences held on this important topic: The National Conference on the State of Canadian Bibliography, held in Vancouver, May 22-24, 1974 and Bibliography for Canadian Studies, Present Trends and Future Needs, held at Dalhousie University, Halifax, June 1 & 2, 1981.

4. Report of the Treasurer: (attached):

In the absence of R. Williams, the acceptance of the report which was distributed at the meeting, was moved by E. Ingles, seconded by Mary Lu MacDonald.

7.8.9 David Kotin, Chairman, Publications Committee reported:

A major change in the frequency of publishing the Papers/Cahiers will be carried out in 1991. After extensive discussions, Council decided to accept the recommendation of the Editor, Bruce Whiteman, to issue the Papers/Cahiers twice a year beginning in the Spring of 1991, and also to mail them out together with the Bulletin, thus reducing mailing costs. The publication programme for monographs will also be revived, taking into consideration the availability of suitable texts and the financial situation of the Society. The new members of the Editorial Board, Papers/Cahiers are Prof. John Hare (University of Ottawa), Prof. Helen Hoy (University of Lethbridge), Prof. Michael Peterman (Trent University). The Society has become a member of the Canadian Association of Learned Journals/Association canadienne des revues savantes, a good forum to discuss common problems.

The Meeting will be held at the time of the Canadian Library Association conference in Montreal in May or June 1991. There will probably be a "minor" presence at the Learned Societies conference in May, at Queen's University, possibly with the Canadian Music Library Association.

There was no other business, but various questions were asked from the floor and answered by E. Ingles and S. Alston on the following topics: there was concern for the up-to-dateness of the Bulletin if it were mailed out with the Papers/Cahiers. The cost of publishing two issues of Papers/Cahiers a year was questioned. The feasibility of using advertisements in Papers/Cahiers to defray the costs was discussed. There were favourable comments on the improved appearance of the Bulletin.

12. **Adjournment:**

A. Steele moved the adjournment at 4:30p.m. All participants were invited to attend the University of Victoria President's reception.

11. 1990 Tremaine Fellowship Report, By Ruth Panofsky

The project for which I was awarded the Tremaine Fellowship is a bibliographical study of the three series of Thomas Chandler Haliburton's The Clockmaker. The first series of The Clockmaker was serialized in the Novascotian between September 1835 and February 1836. It was published in book form by Joseph Howe in January 1837; British and American editions appeared within months of British North American publication. The second and third series were similarly published in Britain, the United States, and France. Howe was soon obliged to relinquish his position as Haliburton's principal publisher to Richard Bentley. Bentley secured the professional loyalty of the colonial author with attractively produced books and handsome remuneration. The international publication and success of The Clockmaker makes it unique among nineteenth century Canadian works, and accounts for its complexity and richness as a bibliographical subject.

The Tremaine Fellowship facilitated a research trip to Britain (9-25 July 1990), where I visited the British Library, Cambridge University Library, the Bodleian Library, and the National Library of Scotland. My primary objectives were to consult the Bentley Papers, held at the British Library, and to locate and examine several Bentley and Routledge books. I knew of the existence of those books from the various rebound copies that I had examined during the course of my research in Canada and the United States. I hoped to verify my conclusions concerning textual provenance by describing the books in their original bindings.

In fact, I located several Bentleys and Routledges in the publishers' bindings. Invariably, the Routledges were those I had been seeking for some time. The Bentleys, on the other hand, were books that I had examined in North America. Further, from a London bookseller I purchased a Routledge which is not included in the many collections with which I am familiar.

In addition to books, I consulted several manuscript collections where I found new and invaluable information concerning the almost instant popularity of Sam Slick in Britain; the financial arrangements between Bentley and Howe regarding the second series; the Paris publication of The Clockmaker by Galignani; as well as the important friendship between Sarah Harriet, Haliburton's second wife, and Charles Darwin.

My investigations in Britain resulted in new knowledge; they also corroborated my understanding of the composition and publication of The Clockmaker series. I am grateful to the Bibliographical Society of Canada for awarding me the Tremaine Fellowship, without which my research in Britain could not have been undertaken.

12. New Work in Progress

Having recently completed A Bibliography of Cookery Books Published in Britain 1875-1914 (London: Prospect Books, 1989), I am beginning work on a new project: a comprehensive, annotated, full-title bibliography of cookbooks published in Canada before 1950, in all languages. As an independent scholar, I am fortunate to have the institutional support of the School of Hotel and Food Administration at the University of Guelph, which wishes to encourage research into food history, for which cookbooks are an essential resource.

Although an important part of the book market and treasured by individuals as indispensable aids in the kitchen, Canadian cookbooks were not collected systematically by any institution before 1950 nor have they been the subject of bibliographical study. Certainly, the search for titles is proving more difficult in Canada than in either Britain or the United States, my previous hunting grounds, where one finds substantial public and private collections of culinary manuals. I should be grateful, therefore, if readers of the Bulletin who have or know of locations of Canadian cookbooks would contact me.

12. New Work in Progress (Cont'd)

I am including publications of 16 pages or more and I am interested in all types of texts, from general works emanating from major publishing houses to fund-raising books compiled by church women's groups or recipe collections put out for promotional purposes by food and manufacturing industries. The aim of the bibliography is to preserve a complete record of a genre that is both culinary writing and a direct window into women's world. It will be an essential reference tool for food historians and a rich source of information for scholars in many other fields.

13. Westinghouse Canada Inc. Deposits Archives with McMaster

McMaster University Library is pleased to announce that it has received the Westinghouse Canada Inc. archives through the kind generosity of the company. The archives are on deposit in the William Ready Division of Archives and Research Collections. The Westinghouse Archives extend to over 10 linear feet and consist of photographs, catalogues, employee magazines, invoices, contracts and general correspondence, dating from 1897 to the mid 1970s.

Westinghouse Canada Inc. (known until 1971 as Canadian Westinghouse Company Ltd.) was established January 27, 1897. Its parent company, Westinghouse Electric Corporation of Pittsburgh, (formerly called Westinghouse Air Brake Company) opened its Canadian branch in Hamilton in February 1897. The Canadian branch was incorporated as a Canadian company in July 1903.

The first president of Westinghouse Canada Inc. was its founder George Westinghouse. In 1866, at the age of twenty, he had invented the air brake, a revolutionary item which would prove to be a safety device for trains. In 1869, he formed the Westinghouse Air Brake Company in Pittsburgh. George Westinghouse remained president until his death in March 1914.

Westinghouse Canada employed 150 men in 1901. By 1906, there were over 1000 employees. Today, Westinghouse Canada Inc. employs over 5,000 people and has plants throughout Canada.

Deposits Archives with McMaster (Cont'd)

The products of Westinghouse Canada, past and present, include air brakes, electrical and mechanical apparatus, small and large household appliances, steam and gas turbines, electronic equipment, nuclear fuel and reactor components, tubes, motors, transformers, switchgear and controls, and generators.

One of the most valuable and interesting aspects of the Westinghouse archives is the extensive collection of photographs which spans the period from 1897 to 1970. There are photographs of company executives, plant workers, buildings, and the products manufactured. Another fascinating part of these archives is the Westinghouse Employees' Magazine. There are monthly issues from March 1943 to December 1946. This employee magazine gives good insight into the working conditions during the Second World War and shortly after. The Westinghouse archives offer many areas of research for students of Canadian workingclasshistory, the history of industry, and Hamilton history. They are a valuable addition to McMaster's archival collections.

14. **Publishers' Papers Project**

Under the direction of Ann Cowan (Continuing Studies) and Carole Gerson (English), the Canadian Centre for Studies in Publishing at Simon Fraser University has received a grant from the Canadian Studies Research Tools Program of the SSHRCC to locate and describe unpublished materials relating to the history of English-language book publishing in Canada. The project includes a systematic survey of institutions and publishers; as well, we would appreciate hearing from anyone who knows about relevant items in obscure locations (especially outside of Canada) or in private hands. We welcome information about the papers and correspondence of authors, editors, publishers, and illustrators as well as the business records of publishing firms. As our findings will be disseminated in published research guides, we also invite responses from potential users of these guides regarding the format and indexing system that would best suit their research needs.
