1. In Memoriam: Bruce Braden Peel

November 11, 1916-November 30, 1998

Canadian bibliography lost one of its outstanding practitioners, with the passing of Bruce Peel. His "Prairie Bibliography" must be considered one of the pioneering monuments of Canadian bibliographic scholarship. A scholar librarian in every sense of the word, he leaves important legacies as a bibliographer, librarian, and Canadianist.

A true son of the Prairies, he was born in Ferland Saskatchewan, received his B. A. (1944) and M. A. (1946) from the University of Saskatchewan, and based his life and career on the West. Except for four years spent teaching, he worked as a librarian. After receiving a Bachelor of Library Science (1946) from the University of Toronto, he worked for five years as Canadiana Librarian of U Saskatchewan's Adam Shortt Collection. In 1951, he joined the University Of Alberta Library, where he spent the remainder of his professional career, serving as Chief Librarian from 1955 to 1982. The University acknowledged his outstanding contributions by conferring upon him an LL. D. (1991), and naming the Library's Rare Book Department after him.

Of his more than 100 publications, approximately one dozen are monographic. Of these, the most famous and enduring is undoubtedly A Bibliography of the Prairie Provinces to 1953 (1956), Supplement (1963) and second edition (1973). Its 4,408 entries serve as the single finest bibliographic introduction to the Prairies that has ever been compiled. Other publications include Early Printing in the Red River Settlement (1974) and The Rossville Mission Press (1974). His last publication appeared in 1993.

Bruce enjoyed a long and fruitful association with the Bibliographical Society of Canada/Société bibliographique du Canada. From 1970 to 1972 he served as President and in 1975 received the Tremaine Medal. Upon retiring from U Alberta in1982, he served for several years as Chair of the Society's Publications Committee. The last conference he attended was in Halifax in 1996, when the Society celebrated its 50th anniversary. Amongst other honours, he served as President of the Canadian Library Association (1969-1970) and received its Outstanding Service to Librarianship Award in 1982.

In addition to his outstanding qualities as bibliographer, librarian, and scholar, Bruce Peel will be remembered as a man of acute intelligence and sensitivity. Behind his soft voice there was strength of character. His energy and productivity could never mask his sense of humour, or his humane and altruistic nature.

2. Minutes of the Annual General Meeting

The annual general meeting was held on Thursday July 15, 1998 in Vancouver, British Columbia

- 3. Approval of the Minutes of the 1997 Annual General Meeting, May 24, 1997 (moved by Jean-nine Green, seconded Bertrum MacDonald)

4. President's Report

The President thanked Peter McNally for organizing the Bibliographical Society of Canada Conference of this date. She thanked Jeannine Green and Joan Winearls for their terms as members of Council and announced that Jacques Michon will stay on the Council an additional year to ensure that our next conference to be held at Sherbrooke Lennoxville in 1999 will be well organized.

Anne Dondertman has stepped down as Secretary; this is a major loss since Anne has served seven years in this capacity. Merill Distad has resigned as Bulletin Editor and Chair of the Publications Committee. Jennifer Connor has resigned as the English Book Review editor. Anne thanked these three for their hard work on behalf of the Society.

5. Treasurer's Report

Elaine presented a written report which showed the total assets of the Society are very stable, that revenue is very slightly up, and that donations have increased. The SSHRC operating grant has ceased to exist in 1998. The Society has undertaken a review of its investment strategy and has changed from a short-term to long-term strategy, and has divided some short-term investments into smaller longer-term instruments which should result in an increase in investment revenue. The annual general meeting and conference showed a small profit in 1997. The Amtmann Fund did not present an award in 1997 and a decision was made at the Council meeting to re-capitalize this fund as a consequence.

Adoption/The Treasurer's Report was moved by Elaine Hoag and seconded by Leslie Howsam; and approved.

6. Secretary's Report

Ann Dondertman could not be present at this meeting, so the President read a message from Anne which announced her reluctant resignation after 7 years to the Society. The President will write a letter of thanks.

8. Report of the Publications Committee

In the absence of the Chair of the Committee, the President noted that there is a present shortage of articles for the Papers. She asked that suitable articles be submitted.

9. Other Business

History of the Book in Canada Project:

Pat Fleming reported that the Director and Co-Director of each volume has been appointed. For Vol. 1, which covers the time period to 1840, Pat Fleming and Jean-Pierre Wallot; for Vol. 2, which covers 1841 to 1914, Fiona Black and Leslie Howsam will serve; 1915 to date, Carole Gerson and Jacques Michon will serve. The names of the advisory board for this project are on the web site. Jeannine Green is the Bibliographical Society member of the Editorial Committee; the UTLAS and University Press of Montreal are co-publishers.

The Project will attempt to find money from SSHRC and will apply as a major collaborative project in 1999. By September 1999 we should know whether the application is successful. There is a web site and a discussion list which will soon be reactivated. David McKnight and Sandra Alston will run the web site. The web site address is www.hbic.library.utoronto.ca

The editors are currently working on 4 items: 1) finalizing the conceptual framework, 2) finding ways to organize the research, 3) ways to organize the bibliographical structure, 4) ways to share out the various tasks involved. Pat Fleming asked for feedback about people's expectations of and understanding about the project.

Tremaine Fellowship:

This year it was awarded to Carl Spadoni for work on Stephen Leacock; the Amtmann Fellowship was not granted this year, since there was no applicant. The Council in its meeting yesterday adopted the idea of a special citation to be given to Canadian institutions from time to time for their contribution to Canadian bibliography. The President asked if this idea was acceptable to the membership, and it was.

Members were notified of the review of the National Library of Canada and National Archive being conducted by Professor John English. A committee was struck to provide him with the views of the Bibliographical Society of Canada. Pat Fleming will send information to this committee from a meeting to be held at the University of Toronto with Professor English.

It was announced that the SHARP Plenary Session to be held on Friday afternoon, July 17, 1998, would be open to our members. Following the plenary session, there will be an exhibition of the books of Lucie Lambert in the old Main UBC Library.

There was a call for papers for the Bibliographical Society of Australia and New Zealand to be held between July 8-10, 1999, Brisbane.

There was a call for papers for the Bibliographical Society of Canada annual conference to be held sometime between June 2 and 13, 1999 (specific date to be announced) at the University of Sherbrooke and Bishop's University (Sherbrooke/Lennoxville, Quebec). This conference will take place at the same time as the meeting of 1. Le groupe de recherche sur l'édition littéraire du Quebec and 2. The Congress of the Humanities and Social Sciences. The papers should be submitted by January 1st, 1999.


The annual conference of the Bibliographical Society of Canada in the year 2000 will be held in Edmonton.

From Michel Brisebois's introduction to the exhibition

In the past, exhibitions on the history of printing have taken many forms. Some concentrated on particular themes or periods of time, while others emphasized technological developments. Aesthetic and documentary qualities of illustrations, first productions of early colonial printers and libraries of well-known collectors have all been the subject of exhibitions.

Of all the reasons to own a book, the main one is certainly to use it, either as a reference tool or for its literary qualities. This exhibition shows two aspects of the printed word: the tool of learning and the communication of public information. The first concerns books people owned, used, read and re-read, wrote in, and often passed on to their children or friends. The book became an heirloom. The second concerns the printed object posted for public reading, and which contained timely information designed to be shared by many: the broadside.

6. New and Recent Publications

Robin Healey's _Twentieth-Century Italian Literature in English Translation: An Annotated Bibliography 1929-1997_ continues Nancy Shields's _Italian Translations in America_, published in 1931. Where Shields included only translations in American editions, this volume contains a comprehensive record of English-language (including Canadian) literary transations. The more than 2500 listings encompass fiction, poetry, plays, screenplays, librettos, journals and diaries, correspondence and some personal narratives, belles-lettres and associated works. It is priced at \$95.00. (Robin Healey is a member of the Bibliographical Society of Canada.)

Long Awaited:

Patricia Fleming's and Sandra Alston's long-awaited _Early Canadian Printing: A Supplement to Tremaine's A Bibliography of Canadian Imprints_ has now been published. The supplement is

an analytical bibliography of previously unrecorded, eighteenth-century Canadian imprints, including not only the standard products of the press, books and official documents, but also job printing. Extensive appendices include a transcription of the accounts of more than thirty years of book and job printing from the Brown/Neilson office in Quebec City. Accompanying the supplement is Marie Tremaine's _A Bibliography of Canadian Imprints, 1751-1800_ which has been reissued by the Press. Both are priced at \$125.00. (Patricia Fleming and Sandra Alston are members of the Bibliographical Society of Canada. Kudos to both authors for this important contribution to Canadian to bibliography.

8. M.A. in English with Speciality in Print Culture 1700 - 1900, Simon Fraser University.

Print Culture 1700-1900" is a new Master's program in English which offers students the opportunity to focus on the changing role of printed texts in an emerging commercial society. During the period, the contours of the now familiar categories of literary studies -- author, reader, text -- were hotly contested, together with the very definition of literature itself. The program is designed to rethink "literariness" and to examine material textuality as it is formed through production, dissemination, and reception of printed, visual, and oral/aural works.

By integrating a variety of theoretical methods with a wide range of historical contexts and resources, the program will introduce students to existing critical debates in ways that will challenge them to develop their own interpretive skills and interests. The interdisciplinary focus of the program reflects the recent shift towards cultural studies

approaches to literature generally. In doing so it creates an interpretive space within which the assumptions of the various approaches can themselves be foregrounded as the basis of critical debate.

Courses will take into account the mutually defining relations between textuality and a variety of cultural fields, including the aesthetic, the literary, the public sphere, economics, sexuality, gender, religion, class, race, and nation. 40th Annual Rare Books and Manuscripts Section PreConference, Montreal, Canada - June 21 - 24, 1999

BORDER CROSSINGS: EXPLORING NEW TERRITORIES FOR SPECIAL COLLECTIONS

Borders are most familiar as geopolitical dividing lines, where cultures collide, entangle, and generate hybrid cultures. But they are also to be found in more conceptual spaces—between tradition and innovation, between ethnic groups, genders, and classes, and even between disciplines and professions. The fortieth RBMS Preconference will explore some of the ways in which the traditional borders of special collections librarianship are being altered at the end of the twentieth century. Particular attention will be given to the convergence of special collections librarianship and digital technology and related issues involving intellectual property rights; to the differences between anglo- and francophone approaches to bibliography; to new developments in special collections public service practices; and to the relationship between special collections librarianship and museum curatorship. The 1999 RBMS Preconference will also feature several workshops and numerous tours of local Montreal sites.
