2. Tremaine Fellowships 1991: Call for Applications

When Marie Tremaine died in 1984, she left the BSC/SBC a generous cash bequest and other benefits, "all to be held by the Society as an endowment, the income from said endowment to be used for such of the Society's purposes as its Council in its discretion may determine." Council has determined to use the income each year to fund Tremaine fellowships in bibliographical research, including textual studies and publishing history, with a particular emphasis on Canada.

The Society will be awarding Tremaine Fellowships in 1990. Committee members are Geneviève Bazin, Michael Treadwell and Karen Smith. An application form is included at the end of this issue of the Bulletin. The application deadline is February 29, 1991. Successful applicants will be announced April 30, 1991.

3. Marie Tremaine Medal: Call for Nominations

The Marie Tremaine Medal is awarded by the Bibliographical Society of Canada/Société bibliographique du Canada for outstanding service to Canadian bibliography and for distinguished publication in either English or French in that field. The Medal will be awarded in 1991, preferably to a member of the Society or to a Canadian citizen. Members of the Council of the Society are not eligible for the award while they are in office.

Previous recipients of the Tremaine Medal have been Marie Tremaine, 1970; John Hare and Jean-Pierre Wallot, 1973; Bruce Braden Peel, 1975; William F.E. Morley, 1977; Reginald Eyre Watters, 1979; Olga Bernice Bishop, 1981; Alan F.J. Artibise, 1983; Douglas Grant Lochhead, 1985; Agnes Cecilia O'Dea, 1987; Sandra Alston, 1988; Gloria Strathern, 1989; and Claude Galarneau, 1990.

The Tremaine Medal Committee—Anne Yandle, Hugh Anson-Cartwright, Eric L. Swanick—now invites nominations for this award. Each nomination must be supported by a biographical note, a list of principal publications, and other relevant information, and sent by February 15, 1991, to Eric L. 6. Publications by Members

Edited by William F.E. Morley, Freda Waldon's Bibliography of Canadiana Published in Great Britain, 1519-1763 has been published by ECW Press and the National Library of Canada. This bibliography of printed works published in Great Britain to 1763 includes books, pamphlets, maps, broadsides and broadsheets which concern in some way any part of the present area of Canada. 7. Call for Papers for BSC/SBC Annual Meeting in Montreal

The 1991 annual meeting of the BSC/SBC will be held at McGill University, Montreal, in conjunction with the annual meeting of the Canadian Library Association on Monday, June 4, 1991.

The Society is issuing a call for papers, the subject of which should be on some aspect of the book-bibliography, analytical, description, or textual; the history of printing or publishing; or the transmission of text. Papers should be approximately 45 minutes long and may be considered for publication in the Papers/Cahiers, the Society's refereed journal. Send proposals for papers, no later than February 1, 1991 to Sandra Alston, the Conference convenor, at the Society's address on the title-page of this journal.

8. Rare Books and Special Collections Interest Group Annual Meeting

Also in conjunction with the annual meeting of the Canadian Library Association, the Rare Books and Special Collections Interest Group of CLA will be holding its meeting on Tuesday, June 4, at the Université de Montréal. The tentative programme is as follows: Richard Landon (University of Toronto) will be speaking on Robert Curzon, 14th Baron Zouche as collector; Roger Lemoine (University of Ottawa) will speak on Louis-Joseph Papineau comme collectionneur; Richard Virr (McGill Libraries) will speak on the Caxton celebrations in Montreal in 1877, and the Université de Montréal library will be giving a tour of the Melzack and Baby collections. A more finalized programme will be printed in the next issue of the Bulletin.

9. Fellowships and Awards

The Society has recently received the following announcements of awards and fellowships:

The Beinecke Rare Book and Manuscripts Library at Yale University has announced the offering of its short-term fellowships for the academic year 1991-1992. Fellowships are awarded in the fields of western Americana, English or American literature, early books and manuscripts and cartography. Intended for visiting scholars pursuing post-doctoral or equivalent research in the Beinecke's collections, the fellowships pay a living allowance of \$1500.00 per month and commuting expenses. The length of the grant is normally one month. Applicants are expected to be in residence during the month of their fellowship which must take place between September, 1991 and May 1992. There is no special application form; applicants are asked to submit a resume and a brief research proposal (not to exceed three pages) to the Director, Beinecke Rare Book & Manuscript Library, Box 1603A Yale Station, New Haven, CT 06520-1603, U.S.A. The proposal should emphasize the relationship of the Beinecke collections to the project and state the preferred dates of residence. The applicant must also arrange to have two confidential letters of recommendation sent to the Director.

The Bibliographical Society of America established in 1983 a programme of short-term fellowships to help support scholars undertaking research associated with the study of the history of books and printing. Eligible topics may concentrate on books and documents in any field, but should focus on the book or manuscript (the physical object) as historical evidence. The fellowship may be held for one or two months and the programme is open to applicants of any nationality. Fellows are paid a

stipend of up to \$1000 per month for travel, living and research expenses. Applications, including three letters of reference, for the programme are due on January 31, 1990. Applicants are invited to contact the Executive Secretary, P.O. Box 397, Grand Central Station, New York, N.Y. 10163 for application forms and additional information about the programme.

The Premio Internazionale Biennale Felice Feliciano has announced a competition in the field of book studies and research. The award will be presented to the author of a text whose theme is the world of books. The theme may be historical, or deal with the current or future state of the book world. Emphasis is given to quality, in manufacture and design, and to the careers of those who have worked in the field. Eligible works will be those published at any time after January 1989, or original unpublished works, in English, Italian, French, German or Spanish. Four copies must be submitted before December 31, 1990 to the Award Secretary c/o Stamperia Valdonega, Via Marsala 71, 37128 Verona. One award will be given adjudicated by an international panel, and presented in Verona on June 1, 1991. The prize is a copy of a prestigious volume and a case prize of five million lire.

10. Editor of the Bulletin resigns

Members of the Society will be saddened to hear that the editor of the Bulletin, Martin Dowding, has had to resign because of ill health. Martin has been editor of the Bulletin since 1988.

11. New Indexer to the Society

Jan Roseneder has been appointed to the position of Indexer to the Society. She succeeds Marilyn Flitton who has been the Indexer since 1979. Ms. Roseneder is a librarian at the University of Calgary Library and the compiler of University of Calgary Theses: a Bibliography and The A.S.A. Index: an Index to Highlights and the Bulletins and Newsletters of the Alberta Society of Artists, 1948-1980.

12. Nominations

Several positions will become vacant at the end of the Society's year, June, 1991. The positions of second Vice-President and three Council members have to be filled. Should any member wish to nominate any other member, or indeed wish to volunteer for a position, would they please write to the Chair, Nominations Committee at the Society's post-box address.

13. BSC/SBC Publications

An updated list of the Society's publications for sale has been mailed with this issue of the Bulletin. The Society is offering for sale this year copies of the second edition (published in 1972) of its Bibliography of Canadian Bibliographies edited by Douglas Lochhead. Members will be aware that the third edition of this work is now in process and due to be published in the next few years. They may however wish to complete their files of the Society's published titles. Copies are available to Society members at the very low price of \$2.00.

14. Notice of Motion - Increase in the Society's Fees

At its fall meeting, BSC/SBC Council unanimously passed a motion to increase fees for membership in the Society, effective for the 1992 membership year (January to December), as follows:

Student and Retired Members - \$15.00 (at present \$10.00)
Regular Members - \$30.00 (at present \$20.00)
- \$40.00 (at present \$30.00)

A motion to confirm this action will be placed before the membership at the next Annual General Meeting of the Society, to be held at McGill University in Montreal, June 3, 1991. At that time Council will also ask the members to authorize further increases in membership fees of up to \$5.00 per year, in each of the two succeeding years (i.e. effective for 1993 and 1994), should Council find it fiscally necessary. This would give Council greater flexibility and allow it to respond more quickly to the Society's needs over the next few years.

Council has taken this position as one necessary to strengthen the financial position of the Society in light of increases in various costs, the impending imposition of the GST and because of the long lead time required by the Constitution of the Society to enact such changes. Council was also guided by the fact that there has not been an increase in membership fees since 1980 and by its decision to publish the Papers/Cahiers on a semi-annual basis, beginning with the next issue, volume 29.

The Society will not register under the GST at this time, which means that GST will not be levied against membership fees for the 1991 membership year. However, as many of the activities of the Society will "attract" GST (such as the production and distribution of the Papers/Cahiers), these added costs will be carefully monitored.

15. American Culture Association

The editor of the Journal of American Culture has written to inform the Society that he is expanding the Book Review section to include the heading "Canadian Publications". He invites members to send publications which in any way represent Canadian, American, or world "culture" interpreted as loosely as possible. Library Receives Grant to Acquire Files of Canadian Authors in the Archives of Dodd, Mead and Co.

McMaster University Library is pleased to announce that the William Ready Division of Archives and Research Collections has acquired the files of Canadian authors from the archives of the American publisher Dodd, Mead and Co. Funds to purchase the Dodd, Mead papers were made possible by a Movable Cultural Property grant of \$ 18,400.00 from the Ministry of Supply and Services - Communications, Canada. The files contain letters written by important Canadian authors, contracts sent to these authors for their signature and revision, correspondence with other publishers, internal memos, sales figures, printing information and publicity material.

Founded in New York City by Moses W. Dodd in 1839, Dodd, Mead and Co. grew from a small religious publishing house into one of the leading publishing firms of the United States. The company continues to flourish to the present day.

McMaster's acquisition of Dodd, Mead papers is exclusively Canadian in character and content. Among the authors represented are: Bliss Carman, Blodwen Davies, Philip Freund, John Murray Gibbon, Grey Owl, W.G. Hardy, Stephen Leacock and Martha Ostenso. The most interesting files are perhaps those of Carman, Leacock, and Ostenso. The Carman material consists of contracts signed by him and correspondence regarding copyright, foreign editions, and the Carman estate. For Leacock there are 19 signed contracts, 19 autograph letters from him, and approximately 220 pages of outgoing and internal correspondence with agents and publishers pertaining to dramatic rights, serial publication, translations and other matters concerning royalty and copyright. Included in the Leacock material is the holograph manuscript of his essay "The Perfect Index", which appeared in My Remarkable Uncle and Other Sketches (1942). Martha Ostenso is also well represented in these papers. In 1925 Dodd, Mead launched a prize contest for a first novel. The winner of the \$13,500 prize was her bleak narrative of family life in the Canadian prairies, Wild Geese. Ostenso's files have the signed contract for this novel, fourteen other contracts, and related correspondence.

With the exceptions of the Macmillan Co. of Canada and Ryerson Press, few publishing records prior to 1950 have survived in Canadian repositories. Although Dodd, Mead and Co. is an American publisher, the material purchased by McMaster from this archive is a significant part of Canada's literary heritage. McMaster University Library houses the publishing archives of McClelland and Stewart, the Macmillan Co. of Canada, Clarke, Irwin, and Peter Martin Associates. The acquisition of the Canadian section of the Dodd, Mead papers will add to the rich resources already held by the Library.

17. St. Bride Printing Library

The St. Bride Printing Library, whose location near Fleet Street is one of the last surviving reminders of the former concentration of the book trades in the City of London, celebrated the centenary of its foundation early in 1991. At the same time it is threatened with imminent removal and possible closure. The International Friends of the St. Bride Printing Library has been founded to represent its readers and well-wishers and to provide support. 18. Canadian Notes & Queries Changes Hands

Canadian Notes & Queries (CNQ) was founded in 1968 by William F.E. Morley, the noted bibliographer and past president of the Bibliographical Society of Canada. Modelled on the British publication Notes and Queries, forty-two issues were published under Morley's dedicated stewardship.

Number forty-three (Winter 1990) has just been published. New editors Douglas Fetherling and Roger Burford Mason have enlarged the focus of CNQ to reflect the subtitle of the mother publication in Britain—"For readers and writers, collectors and librarians". Included in the first issue of the new CNQ are articles by George Woodcock on early British Columbia imprints, Bruce Whiteman on Christopher Dewdney, and Roy MacLaren on Canada's Boer War literature. In addition to the traditional bibliographical notes and queries are matters relating to antiquarian bookselling and collecting.

Canadian Notes & Queries is published three times per year by Canadian Notes & Queries, Box 367, Station F. Toronto, Ontario M4Y 2L8. Fax (416) 538-3317. Rates are \$15.00/year, \$30.00 for two years, and \$100.00 for a life subscription.

19. Carl F. Klinck

Members of the Society will have been saddened to hear of the death of one of our Honourary Members, Carl F. Klinck. Dr. Klinck received his award in 1979. At that time Beth Miller gave the following citation:

Born in Elmira, Ontario, Carl Klinck graduated at age nineteen from Waterloo College, then a part of the University of Western Ontario, and went on to Columbia University, where both his MA and PhD theses were concerned with Canada's Confederation poets. His particular interest during his long career as scholar, teacher, historian, and critic has been the writing done in the English language during the pre-Confederation period in the areas now known as Ontario and Quebec. His great attention to detail and his time spent in the following-up of every clue, however elusive, have resulted in the uncovering of previously unnoticed material, which has, itself, encouraged considerable scholarly study of Canadian works and Canadian writers.

Dr. Klinck's accomplishments are many and varied. Now Professor Emeritus at the University of Western Ontario, he previously held such positions as Professor and Head of the Department of English and Professor of Canadian Literature. In 1965 he was Visiting Lecturer in Canadian Literature at the University of Leeds. He is a Fellow of the Royal Society of Canada and a member of the Modern Language Association and of the Association of Commonwealth Literature and Language Studies. In 1973 Dr. Klinck was honoured by being named an Officer of the Order of Canada, and in 1978 he was awarded the Lorne Pierce Medal by the Royal Society of Canada. Dr. Klinck's writings include the biographies of Edwin J. Pratt: The Man and his Poetry (Ryerson, 1947) and William 'Tiger' Dunlop, Blackwoodian Backwoodsman (Ryerson, 1958). Dr. Klinck, with co-editor Reginald Watters, prepared one of the first comprehensive collections of Canada's poetry and prose in Canadian Anthology (Gage, 1955; revised edition, 1974). With Guy Sylvestre and Brandon Conron, Dr. Klinck undertook the compilation of Canadian Writers/Ecrivains canadiens (Rverson, 1964), a major reference work in biography and criticism. Dr. Klinck was the general editor of the Literary History of Canada (University of Toronto Press, 1965) and with I.J. Talman edited The Journal of Major John Norton 1816 (Champlain Society, 1970). Other writings include Wilfrid Campbell: A Study in Late Provincial Victorianism (Ryerson, 1942) and a biography of Robert Service.
